NEGLECTED CHILDREN. THE CHILDREN'S AID SOCIETY OF LINDSAY.

Annual Moeting-Presentation of Reports -An Interesting Address by Mr. J. J. Kelso, of Toronto.

The annual meeting of the Children's Ald Society was held in the schoolroom of St. Paul's church Thursdey, 24th inst., and was addressed by Superintendent J. J. Kelso, of Toronto, and several

LINDSAY, 24th Oct., 1895, First annual report of the Children's

Aid Society of Lindsay. The society was organized on the Sth December, 1894, and the following efficers elected : president, Mr. D. Ray ; vice presidents, Messrs, J. H. Knight, Thos. Connolly, J. L. Winters, J. R. McNeillie; treasurer, J. E. Billingsley; secretary; Dr. W. L. Herriman; council, Rev. Father Laurent, Rev. C. H. Marsh, Rev. Mr. Shorey, Rev. Mr. Johnston, Rev Mr. Totten, Rev. Mr. Trotter, Messrs, E. Bowes, W. M. Robson, J. L. Perkins, R. Mr. Totten, Messrs; Connolly, Knight, Hore; outing com, all the resident clergymen ; audit com., Mr. Knight, Mr. Bowes ; hon solicitors, Mr. A S Macdonald, Mr. John McSweyn, The constitution and by-laws framed and recommended by the authors of the "Children's Aid" act were adpoted after having been read and considered.

The number of members who joined since organization and paid their annual subscription was 40. The society have held eleven meetings, and interest in its work has been well maintained. The cases of about 25 children have been before the society for consideration. Definite action has been taken regarding several, and a number of others are still being considered by the proper committees,

We have had to apply to the municipal council for financial aid, and this has always been given us cheerfully. The council chamber has also been placed at our disposal for the purpose of holding our meetings; The members of the different committees have realized the importance of the work undertaken and have shown commendable zeal in carrying it on, A vast amount of misery and suffering resulting from vice and indolence has already come under the

observation of the society, and there is practically an inlimites field for the exercise of charitable efforts in this town and vicinity. There can be no more immperative calls on the Christian sympathy of a community than those which this institution is making an effort to respond to-

Kindness and good usage will often do more for a child than whipping or sending it to a reformatory, and moral suasion will sometimes influence parents in the interest of their children better than a resort to law. We have lots of homeless children in Toronto-they drift there from the country and we want to place them back into the rural homes that will be filled with imported children unless we get our own homeless children there.

STRICTLY ENFORCED.

Circular Issued by the Crown Lands esting Notes," referring to the Alaska

Against Killing Moose, To better facilitate the enforcement of the game laws, and with a view of dis seminating a knowledge of the same, the chief game warden for Ontario is sending out the following notice, which will be posted up at all known resorts for hunters: Notice to hunters-Section 2, sub-section 1, of the "Ontario Game Laws" enacts as follows: No deer shall be hunted, taken or killed between the 15th day of November and the first day of November of the following year. Sub-section 3-No one person shall, during any one year or season, kill or take more in all than two deer. Section 14, sub-section 1-No person not a resident and domiciled in the province of Ontario or Quebec shall be entitled to nunt, take, kill, wound or destroy deer without having first obtained a license in that behalf. Section 21, sub-section 1-Any person offending against any of the provisions of sections 2 and 14 of this act shall be liable, for each offence to a fine not exceeding \$50, together with the costs of the prosecution. The provisions of this

The Hos. Commissioner of Crown Lands is also sending out the following circular, with a view to effectually puttinganend to any violation of the laws:

Notice to wood rangers, crown lands agente, crown timber agente, fire wardens, fishery inspectors, or overseers and constables-By section 16 of the fish and game protection act, 1892, all constables, wood rangers, crown land agents, crown timber agents, fire wardens and fishery inspectors or overseers are are vested with powers as deputy game and fish wardens, and are authorized to enforce the provisions of the act, and to receive for their services the same fees as deputy game wardens. It has been represented to the department that, instead of aiding the game wardens in the enforcement of the law, some of the officers aforesaid decline to do this, and that others wink at known violations of the law by hunters, lumbarmen and others. The undesigned desires, therefore, to draw the attention of all the officers above named Mr. Johnston; hon. solicitors, A. S. Mac- either connive at or have a knowledge of the violation of the game laws, without either taking action themselves, or immediately reporting the same to the game wardens or other officers charged with the enforcement of the law, the department will take official notice of their neglect, and where such neglect is wilful or systematic, or where they are themselves guilty o' a violation of the law, or connive at its violation by others, the case will be reported for such action (even to the extent of removal from office) as may be deemed ARTHUR S.
