No Change From last Week-Collections

Reported Good. New York, Nov. 15.-Bradstreet reports that general trade throughout the Canadian Dominion develops no change, when compared with the preceding weeks, and little improvement is expected prior to the close of navigation at the end of this month. At Montreal the tone of general business is firm, and higher prices are expected for many staples. At Quebec City the volume of business is only moderate, and collections are slow. Most shoe factories there are running on half-time, and improvement is not expected prior to Dec. 1. Jobbers at Toronto report a sorting up trade, without special features, except that collections are satisfactory. A fair volume of business throughout Nova Scotia is reported by the leading jobbers at Halifax, who also announce collections are prompt.

The Pickering Insurance Case Grows in Interest

A Witness Badly Wanted and He Cannot Be Found-The Home Lite's Charge Asgainst Alger, Brown and Hortop Now on For Preliminary Hearing.

Toronto, Ontario, November 16:-In the pretty little Assize Court room of the Ontario county court house. which for neatness, cleanliness and cheerfulness presents a strong contrast to the dingy apartment in the York county buildings where the Hyams twins are being tried, the preliminary investigation into the charge of conspiring to defraud the Equitable Life Insurance Company, laid against Geo. E. Alger, was resumed before Magistrate Harper. At 6 o'clock the Crown's case had been presented with the exception of the much wanted testimony of Henry Trull, the local agent for the Equitable Life Company.

Trull had been subpoenaed to attend as a witness, but as he had not appeared at mid-afternoon, a constable was despatched to his home at Oshawa, to ascertain the cause of his absence. Trull, however, could not be found, his family informing the officer that he had left town for a few weeks. His intended destination no person appeared to know, and Detective Murwithout the agent's testimony.

Before the investigation was resumed this forenoon, High Constable Calverley started for Kinsale to apprehend Joseph Hortop, agent for the Ontario Mutual Association, but he met Hortop, who had heard that there was a warrant out for his arrest and was coming in to give himself up. The charge upon which Brown and Hortop are held is that they, together with Steamship Tickets to all points in
Europe by first-class S. S. lines. | Dr. Francey and George Alger, conspired together to defraud the Home Life Association by means of procuring an insurance policy upon Mrs. Alger when they knew her to be in a dying condition. Brown and Hortop were both in a merry mood, and appeared quite confident of establishing their innocence of the crime charged. The court room was well crowded during the day, sensational developments evidently having been looked for. Many of Alger's acquaintances from Pickering were present, and a goodly representation of Whitby's beauty sat in the gallery and watched with interest the proceedings in the court room below.

The proceedings of the day were opened with Dr. Francey. who is charged as co-conspirator in all the indictments, in the witness box. His cross-examination was resumed by Mr. T. H. Lennox, in answer to whose questions Francey stated that he arrived in Toronto from Buffalo about four weeks before the trial at Osgoode Hall. Immediately on arriving in Toronto he went to the Equitable people and told them all about the case, and then wrote to Alger and told him what he had done. Mr. Lennox than began to question the witness about a trip to the Spanish River. Crown Attorney Farewell objected to this ,as it was wandering far afield.

"I see you have been reading The World, and are using their words," said Mr. Lennox. "Yes, I read The World and their words are very appropriate, too," was the retort corteous of the Crown At-

Counsel for the defence then undertook to learn from the witness whether or not he had received letters from other parties who were interested in the conspiracy. His Worship ruled that the witness could not be compelled to give any information about private letters. Mr. Lennox pressed for an answer to his questions and intimated that one line of the defence was that If there was any conspiracy it was by parties others than Alger. The witness finally admitted that he had received letters from the crown and also from other parties, but the latter were private, and had no

Mr. Lennox asked the witness if he could explain why, when Alger was fully aware of the condition of his wife, he should ask Dr. Eastwood to come down and make the examination for the London and Lancashire, "I can't explain it," said the witness, "unless he thought that Dr. Eastwood would help him to grind his axe, the

Dr. Eastwood apparently is not as bad as you are, then?" asked the counsel. "He hasn't been showed up as bad in this case, anyway," replied the

I nreferring to the conversation held in the office of Macdonald & Fitch at Stouffville, Francey denied that he had there said that Alger was innocent of any fraud in connection with the Equitable policy. Francey told Alger in the presence of Macdonald and Fitch that Dr. Eastwood knew that Mrs. Alger was a consumptive and he would put the insurance companies on to the racket. The reply was made to this that "We will fix Lr. Eastwood on that point.

The spicy little conversation refer-

red to by Francy at the last hearing of the case, as having taken place between the witness and Messrs. Macdonald and Fitch, was related at the request of the counsel for defence. Francy said that Mr. Macdonald told him that he would have to stick to Alger, and couldn't be with the Equitable. Fitch also said that if Francy went to the Equitable and told the story, they would have him under arrest at once. This took place subsequent to the conversation in which the witness told Macdonald and Fitch that the whole thing was a fraud. Francy admitted that he had spoken to other persons and told them that if if they would take out a policy in the Epuitable he would pass them. One or two consented, and he passed them, and others refused to enter into such an arrangement. He went to the soof a Mr. Hoover of Whitehall and told him that his father was not in a very good physical condition, and if the son wished to place any more insurance on his father's life, tht he, the witness, would pss him. After the witness had admitted that he was guilty of false representations and conspiracy to defraud, Mr. Lennox asked him if the position of counsel and prisoner was reversed, if he, the witness, would believe Lennox on his oath. "If you was going to get your liberty by telling the truth, there is a possibility that I woull," replied the witness, and the laughter was turned on the coun-

In re-examination, Dr. Francy said that he understood from Messrs Macdonald and Fitch, when at Stouffville, that he would have to swear the whole thing through, as though it was all right. In explanation of certain statements made by Mr. Broughall of the Equitable Life, when the gentleman ws giving evidence last week, the witness said that the application made for a policy on the life of D. R. Bolton was rejected on the face of his

medical report. Mr. Ellitt, mnager of the Standard Bank at Stoffville, produced papers and books showing Alger's financial position with the bank. Soon after Mrs. Alger's death it was proposed by the witness that Alger assign the Equtiable policy to the bank, as a security for the amount due the bank, and the bank would give him an extension of time. When the insurance company learned of the swindle, a writ was served on teh bank for the cancellation of the policy, and the policy was re-assigned by the bank to Alger. Alger paid the costs incurred by the bank in connection with this

The witness said that immediately after this he sent for Francy to come to Stouffville. Francy told the witness that the policy could not be cancelled, as the whole transaction was fraudulent. The witness appeared somewhat unwilling, and Mr. Farewell's leading questions called forth the protests of Mr. Lennox, who contended that the Crown counsel had no right to lead the witness. This matter was settled to the satisfaction of Mr. Lennox, and Mr. Farewell proceeded. a second conversation held the same day in the office of Macdonald & Fitch. Francey at first said it was alright, but again changed and said that Mrs. Alger was a consumptive and Alger knew it. Francey at that time advocated throwing up the Equitable policy because there was so much dirt about the Home Life deal. In that conversation Alger denied that his wife was ever troupled with consumption. Subsequent to this date a conversation was held in the head office of the Standard Bank in Toronto, at which Dr. Francey, the witness, and other officials of the bank were present. The witness admitted at this conversation witness admitted that at this conversation he corroborated in many particulars the statement of Dr. Francey as to the conversation in Stouffville. The witness said that at the conversation in Stouffville, Francey said that he was not going to go down alone. Mr. Elliott's version of what Macdonald said to Francey abotu swearing the thing through was also quite different from that given by Dr. Francey. According to Mr. Elliott, Macdonald's statement was that Francey would be prosecuted by the insurance companies whether he stayed with Alger or

considered him an honest, upright man, worthy of every confidence. When the cross-examination of Mr. Elliott had been completed, Mr. C. Russell Fitch, of Macdonald & Fitch, requested to be allowed to make a statement with reference to the conversation between Dr. Francey, himself and Mr. Macdonald, which took place in Stouffville. Mr. Fitch said that when they were apart Francey and Alger told widely different stories, and it was thought necessary to get them together, to get at the true facts of the case. When the meeting took place Francey at first denied that he had said to Mr. Elliott that anything was wrong. During the whole conversation Francey never asserted that Mrs. Alger had consumption in December, 1894, in fact,; he said he would swear to the truth of his medical report on a stack of bibles a mile high. Francey advocated the throwing up of the policy in the Equitable because of the Home Life deals. He had passed Mrs. Alger in that case without seeing her, and he was not going to take his chance of going to jail for Alger for \$7000. He told them that if they pressed the claim he would go into the box and swear that Mrs. Alger had consumption, in order to clear himself. Alger asked Francey if he had ever told him that she had consumption and he admitted that he had not told him recently.

said that he had had frequent finan-

cial dealings with Alger, and always

Francey said that he was going to swear himself out of it, and stick by those who could protect him. Alger denied all knowledge of the Home Life suspicions of the Equitable policy as his application for a policy on his own behalf was rejected and that for Mrs. Alger was accepted. He said he was being led on by an insurance agent, whose name he did not divulge to Mr. Fitch. To Mr. Farewell Fitch admitted that the writ against The World

was proposed as a means of scaring

the insurance company in the payment of the policy. Edward Wilson of Brougham, a relative of the deceased, Mrs. Alger, was called into the witness box and asked to tell of a conversation he had with Mrs. Alger in July last in reference to her health. The witness was very reticent at first, and said that a conversation had taken place, but he did not want it to come out. For this statement he was sharply remanded by the magistrate, who reminded him that he was sworn to tell the whole truth. In this conversation Mrs. Alger told the witness that she had not seen a well day since the death of her father in January, 1894. The witness said that he knew nothing of the insurance on Mrs. Alger, until the Toronto World published the proposed

At the evening session of the court the charge against Alger, Brown and Hartop was proceeded with, Brown was represented by Mr. R. A. Dickson, of Toronto, with Messrs Don and McGillivray looking after Hartop's inguson and W. F. Eastwood was practically the same as that given by them at the last trial. The purport of Dr. Ferguson's statement was that Mrs. Alger die dof consumption, and that of Dr. Eastwood that Alger had known for years she was so afflicted. Michael Gleson, a store keeper at Greenwood, and agent of the London and Lancashire, swore that he accompanied Joseph Hortop to Alger's a day or two after the funeral, when Alger and Hortop talked about the Home Life application.
