Hyams' Witnesses Fared Badly

CROWN COUNSEL TANGLED THEM.

Yesterday.

Witnesses Became Confused and Contra dicted Themselves and Each Other-Both the Prisoners in Barbers' thairs at the Time Wells Was Eilled, So it is Was said.

Toronto, Nov. 26.-The defence being put up by the counsel for the ligamses twins received a severe chaking up at the hands of Mr. Osler yesterday. No new evidence was submitted, the witnesses examined and the lines of defence folkwed being the same as those at the last trial. The witnesses were placed at the great disadvantage of having to tell their story the second time with-in the six months. If Mr. Osler had not been armed with the sworn statements made by these witnesses at the previous trial, his cross-axamination would not have been so effective as to tie up with a plenitude of contradictions every man who entered the witness box. On the points which have a direct bearing upon the case, their stories were fairly well maintained, but in many particulars, which, though not necessary to the alidi being put up, were excellent tests of memory for men who were swearing to such minute detail of three years ago, there was a confusion worse than that of Babel. It was a failing with every witness to forget matters of very recent occurrence, at the same time recalling with remarkable precision the most trivial incidents of January 16th, 1893. If the memories of the men who gave evidence yesterday

were as defective as to the events of that day as they appeared to be concerning all other days before or since, faint, indeed, would be the hope of the twins for their lives. The defence are trying to prove that Willie Wells was killed shortly after 9 o'clock in the morning; that Dallas Hyams was in a barber shop in Jordan-street at that hour, and Harry in a barber shop in Leader-lane. Three witnesses had sworn on behalf of the defence that at 9 o'clock on the morning of Wells' death they saw Dallas Hyams in his office at 11 King-street rest, when another defence witness upset their testimony by swearing that Dallas Hyams was in the Jordanstreet barber shop from 8.30 until 9.20

He had been sitting in the billiard room at the Albion Hotel with a couple of friends named Deacon and Frawley, when the two latter were seen to rise, and one of them said: "Come. Tom." With this they passed into a little room at one end of the bar, and Kavanagh asked for a "hot whiskey." This was given him, and he poured into it a powder from a white paper, evidently put up at some drug store. To his friends he remarked, that it was something he was taking for his head, and, as he had been complaining of headache, nothing was thought of it. The trio returned to the billiard room and Kavanagh sat down

in a chair by himself. About five minutes afterwards he called out in agony to Marker Martin of the billiard room to come to him at once. He struggled and appeared to be in pain; the legs stiffened and there seemed to be a peculiar twitching of the hands. The suffering man was laid upon the Hoor, and between his struggles managed to gasp out: "Send for the ambulance, boys, I'm done." The ambulance was sent for and everything possible done for the man until Dr. Noble ar-The Doctor suspected strychnine polson from the symptoms, but the man being in a spasm, it was impossible to administer an antidote. That Effect. Dublin, Nov. 25.-Cardinal Logue, Archbishop of Armagh and Prelate of all Ireland, upon the eve of starting for Rome, has issued a pastoral letter, in which he declares that the Pope never stood in greater need of the consolation and support of the Irish people than now. The cardinal censures the British Ambassador to Italy, Sir E. Clare Ford, who, he says, is also the representative of Ireland, for having beflagged the British Embassy at Rome during the recent celebrations in the Italian capital, which scught to outrage and insult the head of the church.

The Pope Again 111. London, Nov. 25 .- A despatch from Pome to The Pall Mall Gazette, says that the Pope was again ill this morning. During last night His Heliness had a chill and coughed a great deal, but did not have any fever.

SAILORS DROWNED.

The Gales on the British Coast Caused Loss of Life. London, Nov. 25 .- The high northeast gale which set in on Saturday continues, and a large number of vessels on the eastern and southern coasts of England and the French coasts have been wrecked. In most cases,

however, no lives were lost. The Norwegian ship Isbaaden stranded near Yarmouth yesterday and broke up before a lifeboat could reach her. An attempt was made to get a line to her by means of rockets, but this failed, and her crew, about a dozen in number, perished. A number of Torbay trawlers were

caught in the gale and made for home. While running into the harbor three of them were dashed upon the rocks and one of them sank. Twenty men were seriously injured.

Channel Traffic Suspended.

Calais, France, Nov. 25 .- The suspension of channel traffic owing to the fierce gales which have prevailed since Saturday led to animated scenes on the railway platforms and steamer piers here. Hundreds of persons have been waiting here for two days for an opportunity to cross the channel and the Terminus Hotel is crowded, large numbers of guests being obliged to sleep upon the floor of the buffet, while anxious crowds swarm upon the end of the pier seeking signs of a coming

The Nessmore's Bottom Damaged. London, Nov. 25 .- The bottom of the British steamer Nessmore, from Montreal for Liverpool, before reported ashore on the Island of Coll. Hebrides, is found to be much damaged. Her cattle were landed Saturday night and her cattle pens are being cleared away, preparatory to the work of discharging her other cargo.

An Important Conference at Ottawa Yesterday.

THE DRAFT BILL AGREED UPON

And Which is to be Submitted for the Approval of the Dominion Government - Mr. Hall Caine's Clear Explanation - Many Questions Answered.

Ottawa, Nov. 26 .- Judging from the

tone of the discussion which took place in the office of the Deputy Minister of Agriculture yesterday, it looks as if the long-pending controversy on the copyright question is almost at an end. This is due in a large measure to the tact and discretion exercised by Mr. Hall Caine, who came over here a few weeks ago properly accredited and authorized to endeavor to reach a settlement. He has been met in a friendly spirit by the Canadian Copyright Association, and to-day there was submitted to the Ministry a draft bill, which has been agreed upon and which if adopted by the Government will end the present difficulty. The sub-committee of council appointed to hear the representations of the interested parties consisted of Sir C. H. Tupper and Hon.Mr. Oulmet. The Premier, however, was an interested listener to the discussion and occasionally took a hand in. The gentlemen present, besides the

M:nisters, were, Messrs. Hall Caine and F. R. Daldy, representing the English authors and publishers; Messrs. John Ross Robertson, D. A. Rose, A. S. Irving and A. W. Rutter, Toronto; and R. T. Lancefield, Hamilton, representing the Canadian Copyright Association; Sydney Ashdown, for the music publishing trade; L. W. Shannon, president, for the Canadian Press Association; W. Foster Brown represented the booksellers. The authors present included Dr. Samuel Dawson, Duncan C. Scott, W. W. Campbell, John F, Waters and Dr. Wyckstead. Officialdom was represented by John Lowe, Deputy Minister of Agriculture; J. B. Jackson, Registrar of Copyrights; George Johnson, Dominion Statistician, and others.

The meeting having been opened Mr. Ouimet called upon Mr. Hall Caine, who rose and briefly outlined the provisions of the measure which is to be submitted to the Dominion Government. He said the agreement was the best that could be arrived at under the circumstances and he believed all would be well satisfied to see its general principles carried into effect. Ross Robertson, president of the Canadian Copyright Association, then said: Our missions to Ottawa in the past have always been to discuss the difficulties of the copyright situation, but on this occasion, as far as the Canadian Copyright Association is concerned, owing to the agreement arrived at between the Association and Mr. Caine, as representing the authors, these difficulties have been removed. By the conclusions arrived at, we have endeavored, and we believe successfully, to deal fairly and honorably with all parties interested, be it the British, Canadian or foreign author and publisher, and as for the Canadian author and publisher, we have not only not deprived them of any rights which they already possessed,

facilities for publication. It is true that there leen mutual concessions on both sides. I do not claim that the Canadian Copyright Association got all that they wanted, or that they were perhaps entitled to; they certainly could not be accused of acting unreasonably, and in saying this I do not pretend that Mr. Hall Caine has not shown every inclination to meet our views as far as he could without endangering the interests he represents.
