I read a short time ago the letter in your paper under the signature "Fair Play" and have waited some explanations of its interjection. As those of our council directly concerned in the case, Mr. McBrian and I, we have explained the transaction to the satisfaction of the public, whose servants they were, would the favor not be just as acceptable? I think these men whom we send to council to spend our money and look after our municipal interests, should not be so slow in replying to a question of so much interest as this late wood deal is and has been - can it be that there is a "singer" in the wood pile, so that the remedy is to drive him out again and with honest and fearless eye face the three squares. Can the wood committee, which has delivered five cords of wood to Mr. McBrian? Did the committee even see the five cords, saying nothing about measuring it? Was the wood first class quality? Was there any hemlock among the wood? Is hemlock worth \$3.75 a cord? Was the last report on the wood question, which was made by the committee of Mr. Hootan? Did Mr. Hootan misrepresent wood when he drew the money and did not the council proceed wisely in their action? I think the wood committee should be held accountable for this case and let the people know something of how their money is being spent by their servants. If their money has been just, why should they fear to write them; it looks to me when they have been silent so long to Fair Play's writing, that there must be a mighty lot to explain, and something of a disagreeable character. Was Councilor Coe's first report an exaggeration? Would the committee, that drew up the last report, swear that the council got "full value" for its money or is this expression only a formal one? Will Mr. McBrian or his wife say that they got five cords of wood from Mr. Hootan? Mr. Editor if some one of the committees on this wood question, does not intend to make any inquiries we must conclude he fears, publicity of his actions, or is deterred from so doing by the reminder that it may break the harmony circle of Cavan's council members.
