Youth Liberated on Technicality

Judge Latchford Liberates Young Man Recently Corrected of Assault

Mr. Justice Latchford Thursday ordered that a young man recently convicted here, should be discharged from custody on the ground that the charge upon which he was tried was defective. According to the material filed in court the accused had a row with another young man, and they came to blows. In the fray the defendant smashed the cheek-bone of his opponent, and he was charged in the police court at Lindsay with assault. The magistrate entered a conviction and sentenced the defendant to one year in the central, without the option of a fine.

Thursday Mr. G. H. Hopkins, K.C. of Lindsay, moved to quash the conviction on the ground of a mis-trial. Mr. Hopkins argued that in the case of a man who elected to be tried summarily the trial should proceed upon a duly formulated charge corresponding in effect with the indictment preferred in cases tried in the County and other High Courts. The magistrate had no authority to try a man upon an information.

"You argue that there should be a document corresponding with an indictment?" asked Mr. Justice Latchford. "Yes, my Lord. Unless a definite charge to which a man has pleaded and on which he has elected, is drawn up and made the foundation of the trial, it must be a mis-trial," replied Mr. Hopkins.

Counsel then proceeded to point out the defects in the substance as well as in the form of the information. Mr. Hopkins argued also that the magistrate had exceeded his powers in making out a warrant of detention to the jailer at Lindsay, directing him to hold defendant and put him to hard labor for a year, or till such time as he might be removed to the Central Prison.

The youth was sentenced to the Central Prison, but no warrant was issued to the governor of that institution to take delivery of the prisoner. There alone could he be put to hard labor. Without a warrant the jailer at Lindsay would have been obliged to hold him till claimed by the proper authorities, but no warrant had been issued to the Central Prison by the magistrate and defendant was therefore held under an irregular warrant.

His Lordship found that the pretended charge on which defendant was tried was lacking in such particulars as time and place and description of persons upon whom the assault was committed, and that therefore the trial was null and void.

Drowned While Canoeing on River

Charles McAlpine of Muskoka Loses His Life on the Severn

While canoeing on the Severn river about a mile below Ragged Rapids last Saturday evening, Charles McAlpine, of Southwood, Muskoka, was drowned. McAlpine, who was a carpenter and was employed by the town at the power house, with another young man took a party of young ladies out for a paddle on Saturday evening about seven o'clock. There were two canoes and when they reached a small chute about a mile down the river, the ladies of the party got out and McAlpine and his friend took one canoe to run the rapids. The canoe upset and McAlpine, who was an expert swimmer, struck out for the shore. He swam about fifteen feet and then without warning sunk like a stone. One of the divers at Ragged Rapids went down to get the body, which was found in twenty-five feet of water. The funeral took place on Tuesday at Southwood. Mr. McAlpine was between 24 and 25 years of age.

Measure on the basis of 100 for a standard condition being a full crop of good quality, wheat fell during the month from 84 to 76, oats from 90 to 81, barley from 83 to 80, rye from 92 to 78, peas from 82 to 75, mixed grain from 89 to 81 and hay and clover from 87 to 82.

The condition of beans at the end of the month was 75 per cent, or one more than at the end of June. Other crops show condition for the end of July of 78 for potatoes, 74 for turnips, 73 for sugar beets, 75 for other roots, 77 for husking corn, and 83 for fodder corn.

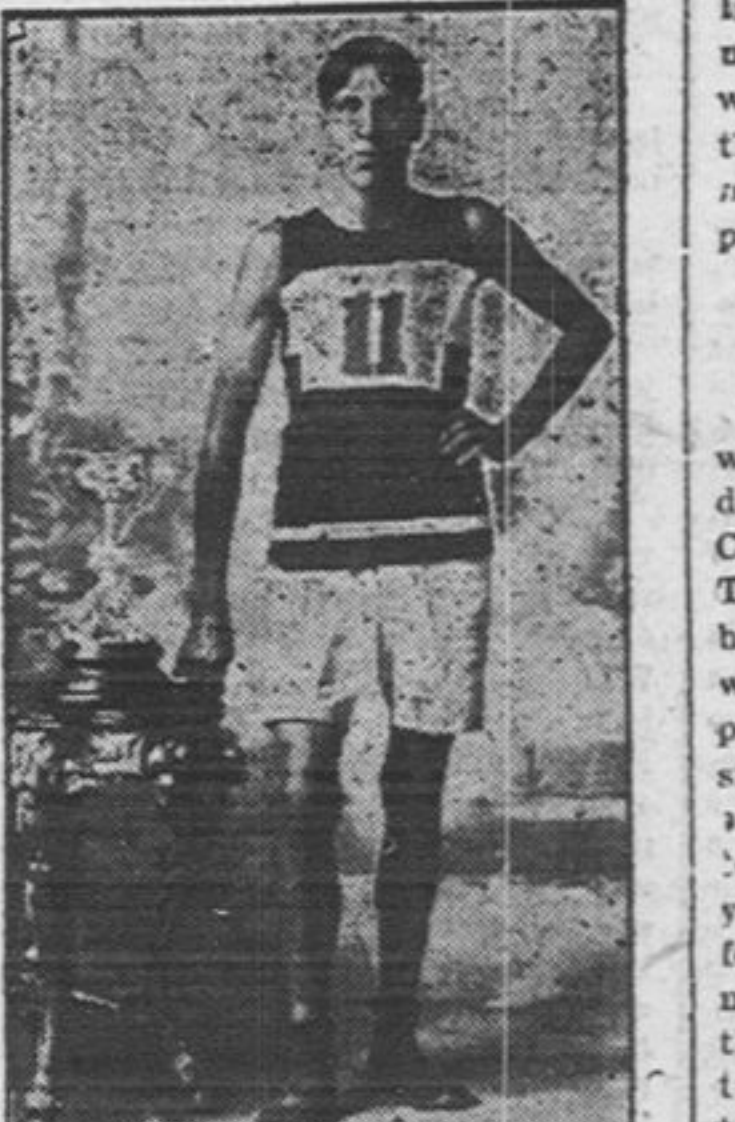

Mrs. Wood missed him from the house and upon making a search found that he had fallen off the slip into about twelve inches of water and had been drowned. Much sympathy is felt for the bereaved parents.

Woman Suicides in Police Court

Tragic Occurrence—this Afternoon in Hamilton

(Special to The Post.) Hamilton Aug. 28.—This afternoon at 1:30 a tragic event occurred in the police court.

A woman had just been tried before Police Magistrate Jells on a charge of keeping a disreputable house. Immediately upon being found guilty by the magistrate she drew a revolver which she had concealed on her person and fired two shots into her own body. She dropped at once, and on being examined by a physician was declared to be fatally wounded.

How it was possible for the prisoner to have a revolver in her possession unknown to the police is a question for explanation.

The Trent Valley Canal

Speaking of the Trent Valley Canal, the Belleville Ontario says:—

"There are only fifty-eight miles of canalized streams to be made navigable, and upon thirty miles of this, from Campbellford to Trenton, work is being rapidly pushed, and surveys have been made of the northern missing link, which, when completed, will open up continuous barge navigation from Port William and Port Arthur, the present distributing point of Northwest wheat, to Liverpool, the chief ultimate market. This will give a route for our wheat, and for an expenditure of ten or twelve millions, four hundred or five hundred miles shorter than the Erie Canal, which will require the expenditure by the United States of \$101,000,000 to make it of even inferior carrying capacity to the Trent waterway."
