TAKING OF PORT ARTHUR TEN YEARS AGO.

How the Clever Japanese Won the Great Stronghold from the Chinese Defending Forces—More than Twenty of the Great Forts were Conquered in a Single Day.

The similarity of the present Japanese plan of campaign to the lines of advance in the Chinese war has been so remarkable that an account of the assault on Port Arthur in the autumn of 1894 is sure to be instructive. It was on Oct. 25 that Count Oyama's force commenced to land at Pitsweo, 25,000 in all, with field batteries and siege guns.

The high water is commanded by two main forts, Etze-shan and Sungshu-shan, and of these Etze-shan has always been recognized by military authorities as the key of the stronghold. On Nov. 21 at 2 a.m. the assault formed up for the final assault from the camp at Tcheng-tau, each man carrying only knapsack and rifle, with their ammunition.

THE TERMS SETTLED

Anglo-Russian Convention as to the North Sea Outrage.

IT COVERS NINE ARTICLES

Commission Under the Convention Will Sit in Paris Probably Within a Fortnight—Five Members Will Compose the Body—Latest Russian Story in Plans of Their Contention—Jap. Official.

St. Petersburg, Nov. 7.—Russia has accepted the telegraphic draft of the Anglo-Russian convention for the settlement of the North Sea incident, submitted to Russia Wednesday, as announced in these despatches at the time, and the final exchanges will be ratified in London. The convention covers nine articles. The commission will sit in Paris, and will consist of five members, Russian, British, American and French. Broad outlines for the inquiry are laid down by the convention.

Secondly—The commission is to report on all the circumstances relating to the disaster and to establish the responsibility.

Thirdly—The commission to have the power to settle all questions of procedure.

Fourthly—The parties to bind themselves to supply the commission with all the necessary information, facilities, etc.

Fifthly—The commission to meet in Paris as soon as possible after the signature.

Sixthly—The report of the commission to be officially communicated to the respective governments, and to be laid to rest added regarding the decision to be reached by a majority, etc.

Three Additional Articles. Sir Charles Hardinge, the British Ambassador, yesterday submitted to Foreign Minister Lamdorff three additional articles of the Anglo-Russian Convention agreement, the first providing for legal assistance, the second for the division of the expenses of the commission, and the third, that the decision of the majority of the commission shall be binding.

LATEST RUSSIAN PLEA.

Japs Organized an Attack From the Hague on Russian's Ships. St. Petersburg, Nov. 7.—A sensational report was current Saturday, according to a high authority, that Russia will undertake before the International Commission to prove that the Japanese minister at the Hague actually organized an attack on the Russian fleet.

Germany Has a Claim. St. Petersburg, Nov. 7.—The Foreign Office has communicated all the documents relating to the North Sea incident to Admiral Knaackoff, secretary to the German ambassador yesterday. Germany has formally asked Russia for an explanation of the Sonntag affair, based upon the claim of the owner of the vessel that he lost that was wrecked by being obliged to leave for fear of being struck by Russian shells.

CHIEF LEGAL RESIGNS.

But He Denies All the Statements of His Accusers. Montreal, Nov. 7.—In consequence of the sensational revelations made in the recorder's court in connection with the disorderly houses of the city, Chief Legal Officer, J. J. Foran, no longer remains and so Saturday afternoon he handed in his resignation to Alderman St. Denis, chairman of the committee of the City Council. The resignation was transmitted to the recorder by Mayor Laporte. Sub-Chief Campbell was at once requested to act as chief of police until the appointment of a new head of the force.

Sensational evidence in this latest police scandal was given in the recorder's court. The case of Madame Lalonde was held before Recorder Pollock and ended on Saturday, when the woman was found guilty of the charge of keeping a den and fined the sum of \$30 and costs. Two Men-at-War At Victoria, B.C., Order of Home.

Victoria, B. C., Nov. 7.—H. M. S. Grafton and H. M. S. Flora have received orders to leave immediately for England. The Grafton sailed Saturday morning. The Flora, from Coquimbó, proceeded without waiting for the Grafton. The purpose of the Pacific station of its two largest vessels is explained at Esquimalt on the ground that more powerful vessels are on the way from England to this station, which since the friction with Russia became acute, has suddenly sprung into prominence as a naval base.

OUR APPLES IN LONDON.

British Columbia Fruit Gained the Royal Horticultural Society's Gold Medal—Britain's Standing Army.

An exhibit is also coming from Ontario.
