out of All and singular that certain parcel or tract of
land and premises situate lying and being in the Township
of Hamilton in the County of Northumberland and
Province of Ontario being composed of the north
half of Lot number eight in the eighth concession
of the said Township of Hamilton

Together with the appurtenances therunto belonging or appertaining To have and To hold the aforesaid lands and premises with all and singular the appurtenances thereto belonging or appertaining ~~Deeds also to the use~~
of the said party of the second part his heirs and assigns for ever ~~Subject nevertheless to the reservations~~
limitations provisos and conditions expressed in the original Grant thereof from the Crown.

And it is hereby agreed between the parties whereof presents that nothing herein contained shall be held or construed to be or to imply any covenant for life or right to occupy or for quiet enjoyment or any other covenant on the part of the said party of the first part
