WHEATON.

H. J. Frayer and H. W. Grote were a couple of sick aldermen last week.

Newman H. Guild, son of Dr. Guild, died Monday, April 28th, after a long and tedious illness. His funeral was held Wednesday and his remains were taken to the Wheaton cemetery.

The town meeting April 2nd, passed off quietly. The republican ticket being elected except assistant supervisor. The officers elected were as follows: Supervisor, John Christy; Assistant Supervisor, H. H. Hopkins; Collector, Joseph Stockton; Assessor, H. Hoff; Commissioners of Highways, Phillip Hadley; Town Clerk, L. W. Mills; School Trustees, R. W. Gates and A. E. Ott.

Circuit court adjourned on Saturday, March 30th, till May, when the chancery cases will be taken up. The last two days of court were mainly taken up with a very interesting case from Downers Grove. It seems a Mr. Daniels, residing at Downers Grove, had a man named Pardee indicted by the grand jury for representing himself to be a deputy sheriff, and as such, entering his house and room on the morning of December 1, 1894, and in so doing creating an unnecessary noise and disturbance, etc. The evidence showed that on the night of Nov. 30, 1894, Pardee, accompanied by a constable from Chicago, having a state warrant for Daniels' arrest, came out to Downers Grove on a late train and stayed over night at Miller's hotel, and in the morning, accompanied by Hofert, the marshal of Downers Grove, went to the house of Daniels, before daylight, and were admitted to the house (Hofert remaining outside) and immediately went to the room occupied by Daniels and wife, for the purpose of arresting him. That considerable loud talking was done by both parties, and that Daniels, who had partly dressed himself on finding out who Pardee was, went for him and ran him out doors, and off the premises on the toe of his shoe. That Daniels was the only person in the party who was armed, and that the constable afterwards disarmed him and made arrangements with him to come to Chicago later, which he did, and was examined and discharged. The jury were out all night and finally brought in a verdict of guilty on the last two counts of the indictment, which charged him with disturbing the peace and entering the house of Daniels without being invited, and refusing to leave when so ordered. The judge fined Pardee \$100 on the two counts. The People were represented by States Attorney Batten and Judge Brown, and Pardee by Mr. Slusser and a lawyer from Chicago. It is understood that there are damage suits growing out of the transaction.


