Adjourned meeting of the board of education was held this evening. Present, Messrs. Blodgett, Carpenter, Lindley, Nourse, Towles and Worley.

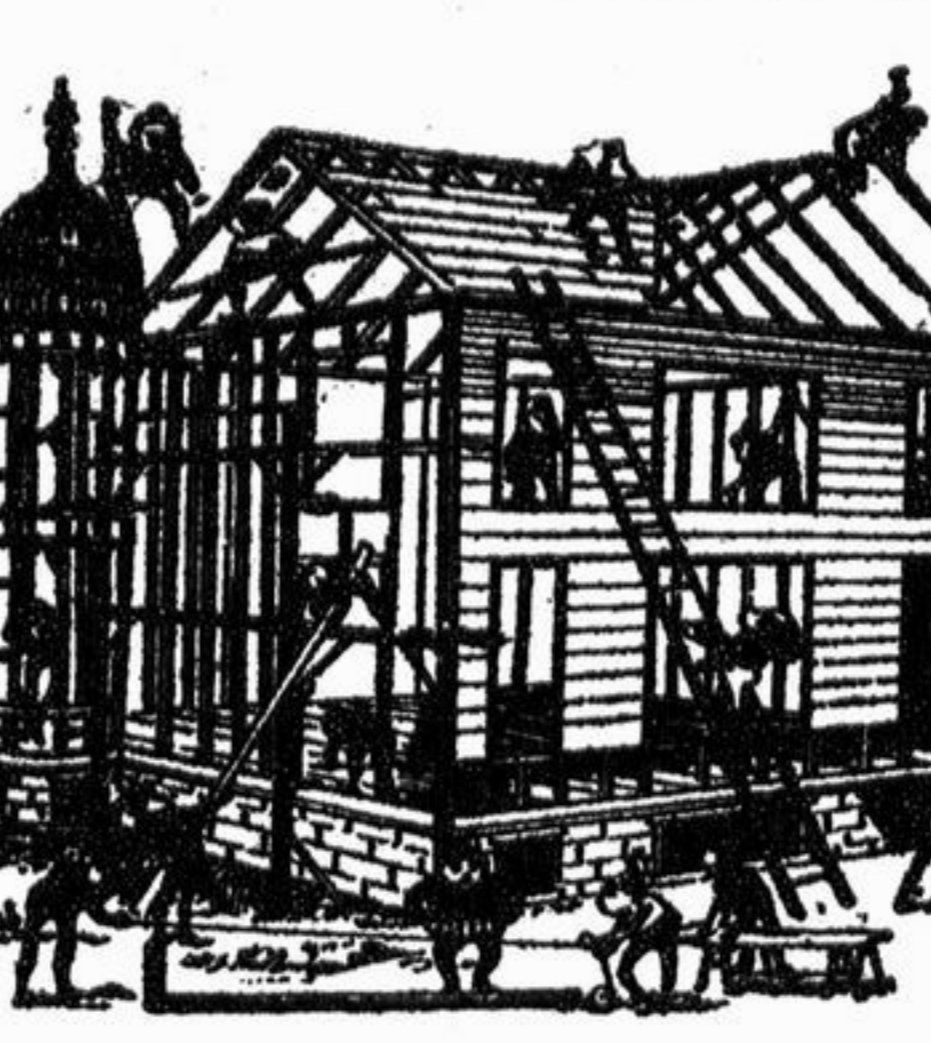
