

AN ORDINANCE

Granting the Chicago Telephone Com pany certain rights in the village of Downers Grove, Illinois, Be it ordained by the president and board of trustees of the village of Downers Grove:

Section 1. That the Chicago Telephone Company, its successors, lessees and assigns, are hereby granted the right to erect, maintain and renew upon and along the streets and alleys of the village of Downers Grove, lines of poles, wires and cable, and to use the same for supplying the general public means of communication by

said village, upon giving to the Chica-go Telephone Company, its successors or assigns, thirty (30) days' written notice of the intention so to do, may terminate all rights hereunder by an ordinance of cancellation.

Sec. 2. All poles erected bereunder shall be located under the supervision of the committee on streets and alleys of the village, and the said committee shall have the right, before the erection of any line of poles hereunder, to change said company's plan for locating the same to some other route which shall be practicable and reasonably direct to reach telephone subscribers, And said poles shall be so placed and maintained as not to interfere with or-ILLINGIS. dinary travel or with any water or sewer pipe; said poles shall be not less than thirty feet in length, shall be smooth well-shaped cedar poles, and shall be neatly painted and kept painted. When it becomes necessary to dig holes in the streets to set poles or replace the same, the company shall immediately repair such streets in a manner satisfactory to said village board:

Any pole or poles which interfere with the public use of any street or alley, or any improvement on or in any street or alley, shall be promptly and within ten days after written notice. moved by said company so as to not interfere therewith.

Sec. 3. No tree or trees in any street or alley of said village shall be cut or trimmed by said company, its successors, lessees and assigns, without the consent of the abutting property

Sec. 4. Said company shall always hold and save said village of Downers Grove free and harmless from any damage arising by reason of said use of said streets, or in any way growing out of the erection and maintenance of said poles and wires.

Sec 5. In consideration whereof said Chicago Telephone Company shall allow the village of Downers Grave the use of its poles and fixtures for the pol-ice and fire alarm wires of said village, reserving on the top cross arm of each pole sufficient space to carry such wires; provided, that the same shall be so placed and maintained by the village Contracts taken for all kinds of Buildunder the direction of the company's general superintendent, and so as not to interfere with said company's use of said poles; said company, its successors and assigns, shall furnish said village, after the establishment of an exchange with local exchange service on village business only, free of charge: One is the waterworks, one in the village hall, one telephone in the office of the village collector, provided that said col-lector is not using an exchange telephone of said company in his premises, and one in each and every fire engine house maintained by said village, so long as said company operates its said exchange hereunder; the usual contract for each telephone shall be prevlously signed for the village by the


Sec. 6. This ordinance shall be in force from and after its passage and the filing in the office of the village clerk of a written and unconditional acceptance of its provisions by said Chicago

Telephone Company.
