And now the annual "sloppy weather" season is again arousing a discussion of the sewer question, and progressive citizens are advocating various plans for awakening an interest in the matter. We suspect that the affair will end in a failure. The matter will be delayed until the streets are improved; (possibly some of them paved), new walks laid, parking places and then the streets will be torn up and the power put down. It is the history of these things in other places, but some people will not profit by the experience of others. The plan advocated last year had its merits, but it stirred up a hornet's nest. But that ought to have been expected. People generally oppose any scheme the first time it comes up, especially if it materially affects the taxes. If a year ago the disposal plant had been put in (the expense ultimately to be borne by the district benefited) it would be partly paid for at the present time, and the people of those sections of the village who desired to unite and build a sewer emptying into such disposal plant could do so at any time when they could agree upon a policy. The other parts of town would not need to be disturbed until such time as they were ready for the improvement. As it is now, no matter whether any division is ready or not, there is no outlet. Many people claim that the reason why the scheme was defeated was because it did not furnish immediate relief to the residents of owners, but it was the design of the sewer enthusiasts to provide for extension as the people were ready. The question is in the hands of the people and it is the desire of the board to conform to their wishes.

Monday William McKinley was inaugurated President of the United States for the second time, as his own successor. This is a distinction which he shared with Washington, Jefferson, Madison, Monroe, Jackson, Lincoln and Grant. The American people can give to no citizen better evidence of their absolute confidence in him—a confidence which is the child of experience—than when they continue him at the head of national affairs. President McKinley begins his second term more popular and more respected than he was when he began his first. He is popular even with his political enemies. He has the absolute confidence of the country. The people are convinced that whatever new questions may come up between now and 1909 will be handled by their tried and experienced Chief Magistrate in that statesmanlike manner in which those grave questions which have arisen since 1860 have been dealt with.

Should the liquor restriction bill now before the legislature be passed in the face of the powerful lobbying opposition of the brewers' association, an end will come to the prolonged and unsuccessful fight which has been made in every suburb against the "blind pig" for years past. The bill provides that the right to sell in original packages or gallon lots shall be held in multi-town districts, thus removing the sole protection of the illicit liquor dealer.

The Chicago, Burlington & Quincy railroad owns more property than any other road in Illinois, according to the state board of equalization. The assessed valuation of the Company's mileage, trackage, building stock and buildings on right-of-way is \$7,736,938. This is more than \$2,000,000 greater than the next highest, the Chicago & Alton, which is valued about \$5,700,000.

After July 1, next, stamps will not be required on bank checks, money orders, telegraph and telephone messages, promissory notes, express receipts, certificates of deposit, conveyances below \$2,500, leases, mortgages, proprietary medicines, pharmacy estimates and sundry other things where the special war tax has been imposed and somewhat hygienic.

It is proposed to amend the inheritance tax law by adding to it the provision that bequests for charitable purposes shall be exempt from the tax. To bring about this result a bill has been introduced in the general assembly which the friends of the amendment hope to have passed.

The days are growing noticeably longer and with their length comes greater warmth from the sun, which means that winter will soon be here. Though March is at hand it will not be long until the farmer will be getting his animals in order in anticipation of spring work.

Early rain in Downers Grove will be a relief to the anxious farmer. The crops are now in the ground and it is the duty of everyone to see that they are well cared for.
