expense, and we would further recom mend that the question of such pur chase be submitted to the legal vot ers of the county at the next annual township elections.

At a meeting of the board on April 21, 1883, Supervisor Churchill pre sented the following preamble and resolution:

Whereas, The people of Du Page county have by a vote at their recent town meetings expressed themselves as being in favor of the purchase of a county poor farm and the erection of suitable buildings for the care of its poor and incurable insane, there-

Be it resolved by this board that a committee of five members of the board, including the chairman, who is to be chairman of the committee, be appointed by the chair to ascertain the cost of a suitable farm, and to receive proposals for the sale of such farm and report to the board at its next meeting.

On motion the above resolution was adopted and the committee appointed by the chair was Supervisors Glos,

Boecker, Gary and Churchill. At a meeting of the board on May 28, 1883, the committee on county

farm made the following report: Your committee appointed to ascertain the price for which a desirable farm could be purchased as a county farm would submit the following:

The Wheeler farm of 129 acres at \$75 per acre; the J. P. Gary farm, 170 or 300 acres, at \$60 per acre; the C. W. Gary farm, 250 acres, at \$60 per acre; the Wadlow farm, 135 acres, with large brick house and good barns, at \$14,000; the David Bronson farm 169 acres, including 15 acres of timber, a good house and two barns, at \$70 per acre; the Bronson (Smalley) farm, 150 or 199 acres, at \$65 per acre. Supervisor Churchill presented the following resolution:

Whereas, The power of the county board to make an appropriation for purchase of a county farm has been questioned, therefore,

Be it resolved by this board. That the county attorney be and he is requested to submit a written opinion to this board at his earliest convenience as to its legal authority in this

At a meeting of the board on September 11, 1883, the following resolution was adopted

Be it resolved. That this board proceed to levy a special tax of \$5,000 to apply on the purchase of a county

Following the above resolution, States Attorney Cooper gave lengthy opinion assuring the board of the legality of its proceedings on the matters in question.

At a meeting of the board on September 8, 1885, Supervisor Cary presented the following resolution: Whereas. The people of Du Page

directed this board to purchase a county farm, therefore, Be it resolved. That the sum of \$10,000 be appropriated for the purchase of such a farm and that the



A. M. Ballou was also present and expressed a desire to refund to the county the \$500 paid to him as part of the purchase price paid to him. He also stated his wife refused to sign or join with him in the execution of a deed of the premises named in the contract with the county.

Your committee further reports there are several minor heirs interested in the title in the farm known as the Ballou farm, thus complicating the same and rendering it difficult to obtain a perfect title to same.

Your committee further reports they have examined the farm known as the Curtiss farm in Milton township and within two miles of Wheaton, which contains 137 acres and which can be purchased for the purpose intended, the title of which is believed to be free from complications and which can be purchased at a less price per acre than the Ballou farm and which in the belief of your committee is more desirable for county purposes. IN LEGISLATION

Foreign Born Holders of British Peerages Subject to Certain Disabilities.

Lord Fairfax, the holder of a Scots peerage created in 1627, whose family have for generations been citizens of the United States, thinks, apparently, that naturalization as a British subject entities him to a seat in the House of Lords, whereas he will only be entitled to vote at the election of Scotch representative peers, or be eligible himself. There are several interesting instances of foreign domicile as a disability, or otherwise. Lord Reay, the holder of a Scots peerage almost as ancient as that of the Fairfaxes (its creation dates from 1628). comes of a family settled for genera- of Lot Eight (8) described as follows tions in the Netherlands. On succeeding bis father in 1876 he took steps to become a naturalized British subject by act of parliament which was passed the following year, and was in 1881 created a peer of the United kingdom.

The naturalization of the holder of a peerage whose family have long been domiciled in a foreign country s guite distinct from the confirmation of his claim to the peerage, which is generally assigned to the lords' committee of privileges. Thus, in 1830, Rev Brian Fairfax, the eighth holder of the title, came to England and had too, in 1869, the tenth Viscount Taaffe, a count of the Holy Roman empire, chamberlain to the emperor of Austria and a general in the Austrian service, had his right to bear the honors of his Irish peerage recognized by the committee of privileges. In 1800 a Dutchman, bearing the title of earl of Athlone, in the peerage of Ireland conferred on his ancestor. De Ginkle, a general of William III, desired as an Irish peer to vote in the Irish House of Lords on the union question, although his predecessors in the peerage had been for generations domiciled abroad. The committee of privileges voted against his admission, holding that he was not British subject.-Pall Mall Gazette.
