OFFICIAL PROCEEDINGS OF THE VILLAGE BOARD

Downers Grove, Ill., Dec. 11, 1911.

The regular monthly meeting for the month of December was called to order by Clerk White.

Roll call noted present Trustees Cook, Barr, Dicke, Handy, Haller and Herring.

The minutes of regular meeting of November 13 were read and approved.

The report of Village Collector for the month of November was read and ordered placed on file.

The report of Village Treasurer for the month of November was read and ordered placed on file.

The report of the Superintendent of Water and Light for the month of November was read and ordered placed on file.

Supervisor C. B. Blodgett appeared before the board with reference to assessment of property of Mr. Edw. Lawson on Randall street. It was moved by Trustees Handy and Herring that claim in the amount of \$9.08 be allowed; motion carried, all voting aye.

Petition was read from Mr. Jay G. Herring, requesting a druggist's permit. It was moved by Trustees Dicke and Handy that permit be granted upon filing of proper bond.

A petition signed by 11 residents of the village asking the board to arrange for a 24 hour electric light service. It was moved by Trustees Cook and Handy that the matter be laid on the table until next meeting; motion carried.

Report of Inspector Kingman of the Hartford Steam Boiler Inspection and Insurance company on condition of boilers at the water and light plant was read and ordered placed on file.
