For the second time in the State of Ohio, profane and obscene language to telephone operators has been placed under the ban. The Public Utilities Commission of Ohio has just upheld the action of the Farmers and Merchants Telephone Company in refusing service to the Canton Transit Company, because its general manager used profane language to a telephone operator because she could not get a certain number for him. In finding that the company was justified, the commission pronounced the following eulogy of "central": "If all the users of telephone could stand for a little while in a busy exchange and see the operators at their work, they would realize what an exacting and nerve-wrecking task they have to perform and would become a great deal more charitable in their criticisms. The occasional misconnections, in a well regulated office is very small in comparison with the thousands of proper connections, and one who uses the telephone a hundred times a day, has little cause of complaint if there is an occasional lack of proper service."

The only previous case of the kind in Ohio occurred 40 years ago the supreme court of the state sustaining the company in refusing to give service to a prominent business man because of his use of profane language to the operators.

JUST OFF THE BAT

Do you remember the cyclone that passed over Illinois a few weeks ago, destroying more than a million dollars worth of homes, business and telephone property?

Elgin, Melrose Park, Wilmette, Joliet, Manhattan, Morris and others about that territory suffered considerably—alright.

There were some people in the community who stuck to the call of Duty, standing and sitting among broken glass, plaster, and bricks, trying to bring succor to the stricken communities.

Telephone operators and plantmen worked like demons. Hours didn't count either. But dismiss the loss of material, although it costs up, by the way, and just let us realize what the disturbance meant to the community at large and the shutting down of telephone facilities.

Everybody breathed more freely when all the telephone lines were restored and service resumed.

Are these girls and plantmen not to be paid equal wages or more, for that matter, than in other channels of commerce?

It is a small item to each subscriber that makes up a living wage to these people who are of your flesh and blood, live in the community, and spend their money in the community and help keep the town going. It is not all profit in the telephone business, by a long chalk. Wages eat up more than half of every subscriber's monthly bill, and if the Telephone Company can't afford to pay them, they go where they can earn it.

Telephone expenses have increased by hundreds of thousands of dollars, but service is a few cents a month more.

There is justice on the telephone side, justice to the workers as well as to those who have lent the public money. Interest in the latter is a very small fraction in the big business of the industry. The bulk of the money earned in the telephone business circulates around your own town.
