**PLANS READY FOR MEMORIAL PARK ATHLETIC FIELD**

hereby empowered and directed to at any time sell (in the manner above described) any part or parcel of the above described land, not deemed necessary for the purpose of an athletic field, if it shall seem to them advisable; the proceeds of such sale to be utilized in improving the remaining portion of said land as an athletic field for the purpose of this trust.

SIXTH: That in the event of the dissolution of the said beneficiary as an active post of the American Legion the said trustees are hereby empowered and directed to carry out the purpose of this trust, for the use and benefit of the citizens of the Village of Downers Grove, State of Illinois, as a public playground or park, and in the event that said piece of land shall be abandoned, by the public as such, or if it shall for any other reason seem expedient the trustees are hereby empowered to sell (in the manner herein provided) and convey in such manner as they may deem expedient and utilize in like manner, or, if the amounts that are realized from such sale are not sufficient for that purpose said trustees may use the proceeds, thus derived in conjunction with funds furnished by citizens of Downers Grove or others, for the purpose of purchasing other land, for such use and purpose hereinbefore set forth.

SEVENTH: That the said trustees shall represent the beneficiary in all suits or legal proceedings, relating to the trust estate in any court.

EIGHTH: That the within described land shall be managed by the said trustees, during the existence of the Alexander Bradley Burns Post No. 80 of the American Legion as an active post of the American Legion, as said organization may direct; provided however that all community organizations and institutions such as the schools both elementary and high school, and such other organizations as may from time to time come into being in the Village of Downers Grove, State of Illinois, may have the use and benefit of the within described land, as the said trustees may deem advisable, or expedient.

NINTH: That the name of the within mentioned field shall be "Memorial Park."

TENTH: That the said trustees shall act as such without compensation.

Now therefore in consideration of the premises, said trustees hereby agree to hold said land, above described to the uses and purposes above set forth, pay all taxes and assessments, and encumbrances thereon, the necessary monies for the same to be furnished by the Alexander Bradley Burns Post No. 80 of the American Legion, as long as it remains an active post of the American Legion, and at the dissolution of said beneficiary as such the said monies are to be furnished by the beneficiaries then having the use and benefit of this trust.

Witness our hands and seals this day of \_\_\_\_\_ A. D. 1921.

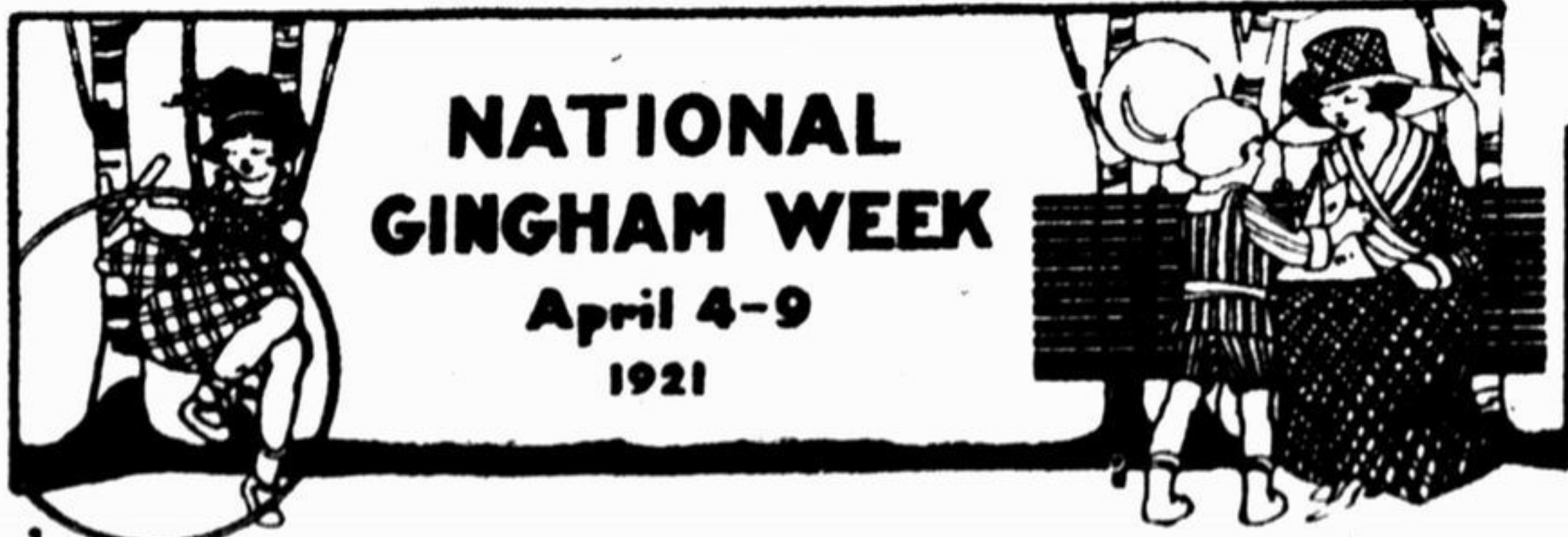
