### FRED REIDELER

Mr. Fred Reiderer, of Benton ave., died last Thursday afternoon, July 21st, after an illness extended over several months.

Funeral services were held at the home last Saturday afternoon, July 23d, the Rev. Arthur Spencer Phelps, pastor of the Congregational Church, officiating. Burial was made at Wright's cemetery, Hinsdale. Mrs. R. E. Rassweiler and Miss Thelma Roe sang Mr. Reiderer's favorite hymns, "Rock of Ages," and "Nearer My God to Thee."

Mr. Reiderer was born in Hanover, Germany, October 19th, 1868. He came to America in 1893 coming to Downers Grove at once and has since made his home here.

November 25, 1895, he was married to Miss Eleanor Perkins, who survives him. Left to mourn his loss also are five daughters, Mrs. Sadie Hubbert, Mrs. Edna Hartsock, Mrs. Eva Curtis, the Misses Nora and Clara and five sons, Burley, a C. P. O. in the U. S. Navy now stationed at Dotham, Ala., William, Edward, Carl and Robert, and three grandchildren, Douglas Hubbert, Eva Hartsock and Betty Jane Curtis.

For twenty-eight years Mr. Reiderer was employed by the Dicke Tool Co., of the village. He was an expert machinist and has been with Mr. Dicke continuously since the plant was established in the Grove.

If Mr. Small is guilty of the charge which has been placed against him he should be brought to justice and made to either serve his sentence or make reparation of some kind the same as an ordinary man would have to do. If he isn't guilty the facts should be made known.

We confess to the fact that the whole thing is rather puzzling to us and that we would like very much to see it cleared up.
