This collection of personal papers gives an excellent view of farm life in Limehouse and area, during the late 1800's and early 1900's
Includes original crown grant for Lot 23, Concession 7, Esquesing Township 1822

Indenture of Bargain and Sale, 14 February 1854, 100 acres, undivided two thirds of Lot 22, 7th Concession, Township of Esquesing between James Young of the Township of Esquesing in the County of Halton, merchant of the first part, Hester, his wife of the second part and Walter Shanley of the City of Toronto, County of York, Francis Shanley of County of York and John Connelly of County of York, of the third part. Mentions mortgage from George Goodwillie of Township of Esquesing, and Orson Towsley who has a claim against property.
- 1.02 Deed of Bargain and Sale: December 10th, 1856, between John Craig, Township of Esquesing, and Peter Laird, Township of Chinguacousy, thirty acres composed of part Lot 24, Concession 6, Township of Esquesing, more particularly described as being of the west end of the northerly half of said lot. Registered in the Registry Office of County of Halton, December 12, 1856 Liber "C" for Esquesing, ? 505, memo no. 558.
- 1.03 Deed of Bargain and Sale: November 22, 1861. Between Peter Laird, Township of Chinguacousy, and Jno Merredith, of the Township of Esquesing. 30 acres more or less being composed of the west end of the northerly half, part of Lot 24 in the Concession 6. Recorded in the registry office County of Halton, December 3, 1861, Liber "E" Esquesing folio 82, memorial 66.
- 1.04 Indenture of Bargain and Sale: November 30, 1866, between John Merredith and Henry Merredith. 55 acres...situated on the north easterly portion of Lot 23, in the Concession 6, of the Township of Esquesing, and being the portion of the said lot remaining unsold at the date of these presents. - composed of the south westerly part of the northerly half of Lot 24 in the Concession 6, of the said Township of Esquesing. Witness to this Indenture of Bargain and Sale was J. John Newton, merchant, Township of Esquesing. Duplicate certificate was recorded in the registry office County of Halton, March 23, 1867, Liber "G" for Esquesing, folio 151, duplicate #81.
