The Stockholm Conference in June will end our first three years of trial and there we shall review our position, take stock of our assets, consider a constitution and plan our activities, including how we, as countrywomen, can help to lift the depression that hangs over the world's countryside.

I believe the reason for our success is we have found exactly the way countrywomen and homemakers in all countries can work happily together. I believe that we have evolved a new conception in international relation-

How is this so? In my own opinion an important reason is that we have embodied in a larger way the principles which have way the principles which have made countrywomen's and home-makers' societies so universally commendable and important in many countries. These are entire independence of each constituent and local body; perfect equality of each society within the larger body; equality of privilege and equality of responsibility; and the realization of the essential part played by mutual understanding, help and friendii-

The next factor is that we are able to keep in constant touch with our Societies, by means of circularizing the full Committee minutes to all Committee members, whether in South Africa or Norway, sending out broadcast large numbers of the monthly leaflet, "Links of Friendship," and allowing (with very great advantage) the attendance of proxies and frequent visitors to the Committee meetings. The next factor is that we are the Committee meetings.

I would next like to emphasize what seems to me to be almost our keynote, namely, that our policy, perhaps at first unconsciously, has been not to build up a big control by the control of big central organization, but to strengthen in every way open to us the development of each of our Societies in its own country. I look forward to the time when the stronger will be increasingly able to help the weaker sisters in practical as well as sympathetic friendship.

I must reckon, too, among our great advantages the contribu-tions and active help of our inditions and active help of our individual subscribers, who, it is likely, will soon be giving us in annual subscriptions as large a sum as the Societies, and the Foundation Friends, whose money and goodwill have enabled us to start an Endowment Fund.

Last, but not at all least, there is the active part taken by the Committee members in London. I am convinced that no other Committee ever gave up so much time to Committee work between meetings—raising funds, doing office work, serving on Sub-Com-mittees, travelling about speaking on our work—in innumerable ways the Committee members have undoubtedly given great

International Committee

Most of our members are aware that an International International Committee known as the Liaison Committee of Rural Homemakers' organizations, with head-quarters at 26 Eccleston Street, London, S.W.1, England, has been a strong factor in creating a splendid spirit of international goodwill through the countrywomen's organizations in some 28 countries with 38 nationally organized rural women's assistance. We are pleased to note a growing and increased interest in the programme for rural women, as evidenced by the or-ganization of a number of branches throughout Ontario during the past year, showing that the practical, educational and social work of the organization is meeting with the approval of

Each year seems to add fresh inspiration to the activities of the branches, and the women generally are more and more realizing the value of the services available from the Instiices available from the Insti-tutes Branch, which aid in raising the standard of home and

ing the standard of home and community life and thus make a very definite contribution to national advancement.

May we emphasize the value of individual effort in making the organization of still greater value through faith into walk. value through faith in the work, faith in oneself and a united effort by Department, Provincial Board and individual branches working together for a definite object, the betterment of hu-manity, through efficiency on the part of the homemaker and homekeeper.

SERVICES OF BOARD

A question which is some-times asked is "what purpose is served by having a Federated Board and what does the gen-eral membership get that was not available previous to its in-ception?"

The Board bears the expense of bringing together a body of representative women elected the members themselves from every section of the Prov-ince for full discussion of business and problems not only common to all but also those peculiar to their respective se peculiar to their respective sections. These contacts, with their varied points of view, are a great stimulus to the members themselves, who in their turn carry the enthusiasm aroused and the fresh viewpoints gained back to their points gained back to their areas to arouse fresh enthusiasm and interest there. This steady and ever increasing interest in the provincial wide aspect of our work has been one of the very poincial around. the very noticeable results of the Federation.

The Provincial Federation is

The Provincial Federation is in its turn a unit in the Dominion Federation, which is again a unit in the world wide Federation of Country Women's Associations. Without its Federation, Ontario, the birthplace of the W. I., which has been taken for an example by these women all over the world, would not only fail to take her place. women all over the world, would not only fail to take her place with all her sister provinces in the Dominion Federation but would alone fail to be a member of this great international or-ganization of rural women ganization of rural women, surely an almost inconceivable situation.

The Board also deals with many appeals which concern the Institutes but not the Department, and which must therefore be decided by the Institutes' official body.

Then a few of the more tang-ible benefits are briefly:

Grants towards financing the various conventions.

Payment of expenses of Federation Representatives to Conventions and of Board members to their District Annuals as well

to their District Armuais as well as to Board meetings. Co-operating with the Depart-ment by contributing toward the expenses of common undertakings such as freight on retakings such as freight on re-lief parcels and shipments, issu-ing this Home and Country News Bulletin, preparing W. I. exhibits, etc., for W. I. wing of Women's Building at C. N. E., preparing Ontario exhibits for the "Ottawa" Exhibition in New Zealand, etc.

Financing and furnishing song sheets to branches and conventions, also financing the "Supplement to a Handy Guide to the Laws of Ontario."

Contributing to support of Dominion and World Federa-tions and this year toward the expenses of sending a repre-sentative to the approaching world wide convention to b held in Stockholm.

Financing Life Membership pins now available under the same conditions as Life Membership Certificates, at an additional cost of \$1.35, postpaid, on application to Institutes Branch, Department of Agriculture, Toronto.

And last, but not least, the Board is prepared at all times to deal with questions of local, provincial or national impor-tance; and to place such, if advisable, before the proper authorities.
