The Executive of the Provincial Board of the F.W.I.O. convened during Easter week. All members excepting Mrs. J. C. Thompson were present.

Wartime activities and suggestions for a working programme covered in lengthy discussions.

Conservation Programme

Attention was given to conservation

Attention was given to conservation of foods, salvage campaigns, buying Canadian, buying British and making the best use of home products. The use of more lard a homegrown product, in preference to imported oils or vegetable products, was stressed.

Jam Project

It was agreed that the Women's Institutes carry on a Jam Making programme again this year. It was recommended that a sugar and fruit fund be established to which Institutes in localities where fruit is not in abundance may contribute.

Suggested Activities

(1) Quilt and Blanket: It was suggested that Institutes collect old used
woollens to be made into blankets.

(2) Skirt and Sweater for adult.

(3) Afghan made of 8 inch square

blocks, wool.

At the moment we are greatly cheered by the sinking of the Bismark!
