President's Address

Mrs. Duke expressed the honour which had been hers in serving the Women's Institutes during her three year term of presidency. She extended appreciation to the directors, executive officers and members for their loyalty and co-operation at all times. She hoped that the W.I. programme would not be curtailed in any way and assured members of her con-

gramme would not be curtailed in any way and assured members of her continued support and best wishes.

In her resume of her activities Mrs. Duke reported that it had required well over one hundred days from home. There had been many invitations which she had been unable to accept and in all cases greetings and regrets for absence had been sent. As president and conveyer of the Central Fegrets for absence had been sent. As president and convener of the Central Fund (War Charities) Committee some 215 personal letters had been written, as well as circular letters.

Superintendent's Report

Miss Mary A. Clarke, superintend-Miss Mary A. Clarke, superintendent, brought greetings from the Department and addressed the Board members. She stated that she was encouraged about the work of the Women's Institutes in Ontario as evidenced at conventions and in reports. The superintendent called upon the directors to support the Home Economics programme. The need for stimulating interest among younger women was pointed out as reports some-

men was pointed out as reports some-times showed too high a proportion of

times showed too high a proportion of older women at meetings.

This year nutrition work is being carried on in seventy-five districts. The Women's Institutes have pioneered in nutrition in Ontario, and are continuing this activity, taking their part in the Canadian nutrition campaign. To meet the problems facing homemakers today, a new study on household budgeting is being planned.

The Superintendent favoured the organization working toward the establishment of "equal educational opportunity for all children". She re-commended that Institutes continue activity in this field.

Secretary-Treasurer's Report

Mrs. W. B. Leatherdale reported that during the federation year more than 1,200 communications were written by the secretary. 9,576 W.I. song sheets, 164 hand books and 90 W.I. pins had been distributed.

The financial statement showed a balance of \$1,746.90, but expenditures for the year had exceeded receipts

balance of \$1,746.90, but expenditures for the year had exceeded receipts by \$349.05. (See page 4). According to federation fees received there was a falling off of some 2,500 members during the fiscal year. This was attributed to the movement of young women and many rural families to larger centres to take their place in war industry. war industry.

The secretary was instructed to write to Welland County Women's Institutes thanking them for their generous voluntary remittance of 15 erous voluntary remittance of 15 cents per member, rather than the usual 10 cent federation fee, to help swell the treasury.

Standing Committees

The tentative Outline of Functions of Standing Committees was presented to the Provincial Board by the superintendent and was endorsed. This is now available to Institute, district, area and provincial conveners of standing committees of the Women's Institute.

There was lively discussion following the Publicity report and it was agreed that generally speaking Institutes could spend more for publicity and that this should be considered in relation to the total budget. Reference was made to Mrs. Price's publicity suggestions in "Federated News" as a guide.

War Work

Mrs. L. W. Challand reported the large amount of war work done and money raised for war charities by the combined efforts of the members of the Women's Institutes in the Province.

From figures reported, money raised for war work last year totalled \$124,-376.83, knitted articles 126,807, articles of sewing 104,300. Among gifts of money, designations were made to the F.W.I.O. Central Fund, Jam For Britain, Sugar Fund, Canadian Red Cross, The Navy League, British War Victims' Funds, Russian Relief, Milk for Britain, gifts for enlisted men and other funds.

Stamps, certificates and bonds were bought by practically all Institutes.

Central Fund, F.W.I.O.

Mrs. Duke, as convener of the Central Fund, reported the year's activities. Receipts from January 1st to October 31st, totalled \$5,081.19, and, with amount brought forward, \$9,388. 03. After meeting expenditures to date a balance of \$1,675.62 was on

ed by the superintendent showed receipts of \$2,163.66 from 298 contribu-

ceipts of \$2,163.66 from 298 contributions. Seventy tons of jam and honey
had been shipped out of Toronto and
it was hoped to meet the objective of
300,000 pounds. Provincial directors
from the fruit-growing areas expressed themselves in favour of seeing the
jam project continued next year.
