The Agriculture and Canadian Industries report was dealt with by the convener, Mrs. F. E. Birdsall. Members were urged to keep farm accounts and were urged to keep farm accounts and to give more consistent support to boys' and girls' clubs which are necessary to provide education, recreation and inspiration for the young people of the rural districts. She spoke of the necessity of improving the standards of quality to retain postwar markets. The Home Economics outline presented by Mrs. G. Wilmer Keyes was in the form of a questionnaire and would make a most interesting program for one or a series of meetings.

Mrs. T. D. Cowan, reporting for the Citizenship Committee, commented that reports from the Area Conveners show that the Institutes have done much to impress upon their members the three characteristics of a good citizen—Intelligence, Integrity and Industry. A resolution had come from the Timmins Area asking that, in from the Timmins Area asking that, in the oath of allegiance, a clause be inserted swearing loyalty and fidelity to Canada as well as to our King. Members are asking if there is any reason why the word "Canadian" should not be given meaning, since Canada belongs to the Commonwealth of Natios A recommendation was passed. tions. A recommendation was passed that Mrs. Milton Wade, Dominion Convener of Citizenship be asked to contact authorities at Ottawa re these matters.

Mrs. J. Reid, reporting for Social Welfare asked the members to continue the study of the Planning and Housing Memorandum of the A.C. W.W. They were advised to become familiar with the Family Allowance Bill which will become law in July.

"Our aim is a Tweedsmuir Village "Our aim is a Tweedsmuir Village History in every Institute by 1947," stated Mrs. G. Gordon Maynard in presenting her report on Historical Research and Current Events. This will fittingly mark the fiftieth anniversary of the Women's Institute movement. It was agreed that the Provincial Convener of this committee be

vincial Convener of this committee be made a new member of the Ontario Historical Society.

To mark the Silver Anniversary of the Provincial Federation a Provincial Tweedsmuir Women's Institute History will be compiled. Mrs. Maynard with Mrs. Summers and Mrs. Leatherdale were named a committee to be responsiible for the history and the purchase of a suitable book. A recommendation will be made to A recommendation will be made to the National Federation of Women's Institutes to include Historical Re-search among the F.W.I.C. Standing Committees.

Publicity-How to interest women of the community in the Institute program and to put across its aims and ideals was the keynote of the convener's outline for activity. Publicity articles by her pen had been farreaching.

Members are reminded that the reports and outlines of conveners of the respective standing committees may be had upon request from the Loan Library, Women's Institute Branch.

War Work Committee

Some 960 Institutes or 74.2% reported. Mrs. L. W. Challand, the convener stated: "There is much more to this war work of ours than can be estimated in money value. A well-meaning Government might have meaning Government might have spent our \$173,500.86 during the past year but could it possibly have meant as much to either the receiver or to those who gave? Just touching the garment that someone at home has handled, or made, unpacking the box that someone has lovingly filled, makes the homesick lads or the hungry, homeless folk feel that someone cares and they take fresh courage".

The spiritual side of our war work was stressed by many of the conveners and by one in these words: "We must throw a shield of prayer around our service men and women and ask for a new loyalty and devotion to inspire our country and the nations of the earth that all may work together under God's Guidance for a new world of peace and unselfish freedom for all mankind".

Central Fund

Receipts to October 31st totalled 87,307.67 and expenditures to war charities \$6,181.57, leaving a balance of \$1,116.10. This was reported by Mrs. H. Wicks, Secretary-Treasurer of the Central Fund Committee.

Institutes Disbanding

Because of occasional requests from Institutes for correct procedure in dis-posal of assets when disbanding, Mrs. E. A. Duke and Mrs. F. Barron were named a committee to bring in a recommendation to meet this need. The following resolution was adopted:

"That the following procedure be followed by Women's Institutes which consider disbanding:

1. Notice of motion to disband should be made at a regular meeting, to be voted upon at the next regular meeting; and a copy of the notice of motion should be sent to members not present at the meeting at which paties of motion was given which notice of motion was given.

If this procedure is not possible notice of meeting must be sent all members, stating reasons, two weeks previous to meeting.

- 2. All assets should be disposed of by a two-thirds vote of the members present.
- No Women's Institute having disbanded shall re-organize within a year.
- The Women's Institute disbanding shall notify the District Secretary who in turn shall notify the Department.

F.W.I.C.

Each of the provinces has been asked to prepare a brief to be circular-ized to all Provincial Federations prior to the Biennial Meeting of the F.W.I.C. which will be held some time during 1945. Mrs. Holmes, Mrs. Summers and Mrs. Leatherdale were named the committee to prepare the Ontario brief for consideration at the Spring meeting of the board.
