HIGHLIGHTS OF THE APRIL BOARD MEETING

Many salient points were brought to the fore at the April Board Meetto the fore at the April Board Meeting this year. Since you will have heard a full report of this meeting at your district annual we shall bring to your attention only a few of the major considerations.

50th ANNIVERSARY PLANS
February 19, 1947 will mark the 50th anniversary of the founding of the Women's Institute at Stoney Creek, Ontario.

To commemorate the founding of the Women's Institutes it was decided that a sinking fund be established for the purpose of (a) establishing Adelaide Hoodless Scholarships for entrance to Macdonald Institute and (b) a Women's Institute Foundation at Stoney Creek. Since Adelaide Hoodless was so keenly interested in the education of our rural women and girls in the Art of Homemaking and since the Home Economics course at Guelph was started as a result of this interest it was thought fitting to commemorate this anniversary by establishing these scholarships. Thus we would be aiding our own rural girls in attaining better Homemaking practices.

own rural girls in attaining better Homemaking practices. From Stoney Creek, the Women's Institutes have spread until we are now a world organization "The Associated Country Women of the World". Many members all over the world will want to visit the site of

the first Institute.

To finance the above and to help finance an appropriate provincial celebration it will require the equicelebration it will require the equivalent of one dollar per member from each Institute, to be raised in whatever manner the individual Institute sees fit. This should be paid through the district secretary-treasurer to the Provincial Secretary-Treasurer by November 1, 1946.

HAND BOOK COMMITTEE

3. That every member of the Institute should feel free to send in suggestions re revision of Hand Book.

4. That the Hand Book Committee

review the constitution of other women's organizations of similar type. women's organizations of similar type.

BEVERAGE ROOM BRIEF

The Women's Institutes of Ontario stood on record this year by calling together representatives of the various women's organizations in Ontario ious women's organizations in Ontario asking them to stand united in an effort to abolish women's beverage rooms. Mrs. J. R. Futcher, Board Member for Subdivision 14, presented this brief to Premier Drew and was accompanied by a delegation appointed by the committee formed of representatives from Provincial Women's Organizations. We present the brief in part:

"We represent the rank and file of the sane-thinking women of Ontario, both urban and rural, and we are standing together in defence, against an evil that is undermining our homes. This evil is Women's Beverage Rooms. We consider Women's Beverage Rooms the most immoral and degrading force ever existing in our Province. We feel we see the service of the sane work of the sane of the san

grading force ever existing in our Province. We feel we can no longer tolerate them because of the conditions which they produce.

It has always been woman's res-

ponsibility to keep the moral standards of civilization on as high a plane as possible. But these moral standards of civilization can be no higher than its womanhood. We are fearful of the destructive force the Women's Beverage Room is wielding. There has been an alarming increase in illegitimacy, juvenile delinquency, venereal disease, and divorce in our Province. While we know this increase is not entirely due to the Women's Beverage Room, it is common knowledge that it is the greatest contributing factor. For the protection of our womanhood and the present and future safety of our homes, this evil must be abolished."

In reporting to the F.W.I.O. Board, Mrs. Futcher stated: "While the committee was disappointed that the brief did not bring the results hoped for, still we were assured by both the Minister of Agriculture and the Premier, that the brief had been of influence in framing legislation". "Now", said Mrs. Futcher, "we have the opportunity of taking the vote in our own local communities".

FINANCE COMMITTEE

The following recommendations of the finance committee were approved:

1. That a contribution of 1 cent per member per year be made by the Institutes of Ontario to the A.C.W.W.

2. That a contribution of 2. Inat a contribution of 5 cents per member per year be paid to the F.W.I.C. The suggestion was made that the collection at the February meeting be F.W.I.C. month collection and that 5 cents per month be remitted through the proper channels to the F.W.I.C. 5 cents

A proposed increase in the membership fee from 25 cents to 50 cents per member was brought before the Board by the finance committee After a lively discussion it was decided that each board director discussion it was decided that each board director discussions are considered. the advisability of this increased fee at the District Annual. Further investigation and discussion will take place at the November meeting.

place at the November meeting.

Many requests had come in regarding a raise in the fee: Institutes now find with their financial obligation to the district, the convention area, the Board, F.W.I.C. and A.C.W.W. that the 25 cent fee no longer covers the amount paid out per member. When first our Institutes were organized, there were only the local Evanches there were only the local Branches to consider. Now that our horizons have widened and we are organized provincially, nationally and internationally, our responsibilities as well as our opportunities have increased.

NEW RULING PERTAINING TO BRANCH LIFE MEMBERSHIP In order that Life Membership may be transferable from one Women's In order that Life Membership may be transferable from one Women's Institute to another in Ontario, should the holder move to another Women's Institute, it is requested that the \$5.00, formerly paid to the branch treasury, now be forwarded to the Provincial Secretary with the application form. This relieves the Women's Institute converged from paying the Institute concerned from paying the yearly Federation fee of this member.
