AREA Conventions are over for another year, and for the second time I have had the privilege of attending all of these gatherings in every area of our Province. I have finished the work, filled with inspiration given me by you, the Women's Institute members met in conventions. appear that they have well over \$20,000 lying in the Bank at bank interest only (1½% or less) instead of having this money invested at twice or better than that income, and I understand that they are contemplating asking us to increase our payments to them.

I would also like to point out that F.W.I.C. now receives more from the Ontario Junior Farmers' Association than does the F.W.I.O. We receive a \$50 Affiliation Fee from the Junior Farmers' Association, whereas F.W.I.C. receives 7c per Member. We have 1,023 Junior W.I. Members, which at 7c is \$71.61—hence F.W.I.C. receives \$21.61 more from our Junior W.I. Members than we do.

F.W.I.C. Financial Statement is Bi-ennial; ours is annual. Their statement for the last bi-ennial term shows approximately \$6,000 received from all Provinces for Membership Fees; whereas F.W.I.O. sends them approximately \$3,000 per year, contributing approximately \$6,000 in the TWO years. The Statement which I received was NOT an Audited Statement. Therefore, I would suggest that a Motion be passed at this Board Meeting requesting F.W.I.C. to submit to us an Audited Copy of their Bi-ennial Financial Statements immediately following the close of their fiscal year and bi-ennial terms.

Agriculture and Canadian Industries by Mrs. Stewart McDonald.

"Agriculture is a basic industry, a science and an art," said Mrs. McDonald. "It is the industry that produces food without which no human being or animal can exist. Food is the greatest ammunition for peace. Life depends on food and therefore on productive land. Agriculture is a God-given way of life: the man who follows it may be proud of his profession. His is, and must be, an example to the world of the quieter way of life, of the concept of the relation of man and his stewardship to his Creator."
