That the Ontario Department of Education be asked to include a short course of lectures in safe driving and courtesy on highways in the curriculum of secondary and vocational schools where such courses are not now available.

That the F.W.I.O. respectfully request that a campaign be conducted to have every person arrange to have his or her blood typed and be arged to carry a card in purse or car, indicating type.

That legislation be enacted whereby trees, undergrowth, etc. be removed 500 feet from intersection of all roads in the Province of Ontario. That "Beware" signs be erected at all intersections and that excessive dust be controlled for 500 feet at all intersections—this on account of fatal and serious accidents occurring because of these conditions particularly in some areas of the North.

That manufacturers of overalls and work-pan's use better material and that pocket material be stronger and pockets be deeper. There was much discussion on this resolution but it was brought out that these garments bought in the U.S.A. at comparable and below Canadian prices are of better quality material. The resolution was sustained, amended to read, "to make the product more comparable to the same product made and sold in the U.S.A."

That Christmas Day continue to be held on December 25th.

Resolution passed by the A.C.W.W. in Ceylon that thermo-nuclear weapons for destructive purposes be forever held in check and be used for the universal good of mankind, was supported unanimously by the Board.

A resolution requesting the Canadian Association of Consumers to urge paint companies of Canada to return the pint size cans to the market.

A resolution stating that because the National Housing Scheme does ruthlessly cut down trees, and because houses are so crowded on streets in new subdivisions, the N.H.S. is asked to strictly enforce building regulations in the subdivisions.

That the Provincial Government be respectfully requested to consider a change of policy to allow the sale of small articles of metal and woodcraft made by boys at the Ontario Training Centre. At present these are broken up and often thrown away, causing discouragement to the pride of the boy who has produced or created them. This resolution is to go also to the John Howard Society and the Elizabeth Fry Society.

That a law be passed requiring pupils to cross the road in front of the school bus. That snow fences and other highway equipment be made available to the taxpayer when no longer required by the Department of Highways.

That older patients requiring nursing care and unable to gain admission to hospitals qualify, upon doctor's recommendation under health insurance schemes, for nursing care in their own homes.

That the junction of highway 17 and 548 in the Sudbury area, being very dangerous, the Department of Highways be requested to install flashing caution lights at this junction.

That it be made compulsory for all manufacturers of shortening and margarine to have printed plainly on all packages what type of fat or oil (vegetable or animal) is used in the product.

The Savard Institute in Cochrane, Temiskaming Area, requests the Government to send a dental coach out to the district. The community has no dentist and school children are in immediate need of dental care.

Requesting the On ario Government to make the area surrounding Aubrey Falls on the Mississaga River into a provincial park. (The Ontario Hydro is planning a power development on the river which may destroy this natural tourist attraction.)

That tranquilizing drugs be obtained only with a physician's prescription.

That the Federal Government be asked for reimbursement for deaths of domestic animals and heavy medical expenses for animals and humans resulting from rabies in many Ontario districts.

Asking members of the Women's Institutes to acquaint themselves with the growth and spread of weeds, including new ones, presently increasing problems to farmers and property owners; to destroy them when they can, and to assist the weed inspector whenever possible.
