similar to butter; that the Red Ensign be chosen as the distinctive Canadian flag; that the Attorney-General be requested to make mandatory, the "breathalizer" and blood tests where there is occasion to determine sobriety or "impairment" of a driver of a motor vehicle; and that, because minimum penalties for driving while under the influence of liquor are not sufficient to be a deterrent, these penalties be reviewed with a view to increasing minimum fines and jail terms.

A resolution asking the Government to extend Hospitalization benefits to all nursing homes, so that citizens requiring nursing care will not have to go to designated nursing homes at some distance to receive the benefits of their

paid up hospital insurance.

A resolution requesting the Government not to relax the laws regulating Sunday sports, since "any relaxation of these laws would lead to further relaxation with a detrimental effect on the moral life of the country as a whole

and of young people in particular."

Resolutions requesting the Ontario Department of Health to revise the Hospital Insurance Plan to continue coverage of children still financially dependent on the parent; requesting the Department of Education to introduce a course in conversational French in the elementary schools of the province in an early grade; resolving that "on the death of a husband or the separation of a husband and wife, the furnishings of the home be deemed to be the property of the wife"; resolving that whereas in supermarkets packages of soap, and foods are marked so many "cents off" without stating the regular price so that the customer does not know the true value, "therefore the regular price should be clearly marked as well as the reduced price", resolving that it be made compulsory that all minor league hockey players wear helmets; that when materials on the market for clothing and draperies have a design printed off grain, the manufacturer be compelled to have such material stamped "Off Grain".

The Board supported two resolutions from the Women's Committee of the Ontario Federation of Agriculture, which had been passed at the 1961 annual meeting of the O.F.A.

The first of these resolutions expressed appreciation to the Ontario Government for existing legislation prohibiting the manufacture and sale of butter substitute coloured to resemble butter, and requested that this legislation be retained and enforced.

The second resolution on Estate Tax and Succession Duties reads: "Whereas in establishing Succession Duties and Estate Taxes, valuators of farm property frequently arrive at an amount beyond that which can be obtained on the current market; and whereas farm estates

may have to be sold at prices below the true value to provide funds with which to meet the cost of Succession Duties and Estate Taxes within the prescibed time for payment; therefore be it resolved that the Federal and Provincial Governments be requested to amend the legislation concerning Succession Duties and Estate Taxes to provide: (a) An extension of time in which payment must be made so that sacrifice sales will not be necessary. (b) Refunds by Governments to the Estate of the difference between the tax on the value which the valuator placed on the property, when it has been necessary to sell a farm property to provide funds with which to pay Succession Duties and Estate Taxes. (c) That values placed on farm property by Succession Duties and Estate Tax valuators bear a closer relationship to values by other Government Depts.

## Entertainment

The retiring Board Directors entertained at an evening party which, in keeping with the 65th Anniversary Year, featured the home entertainment popular at the turn of the century. Eight lively square dancers performed with great agility and the various entertainments and contests were most enjoyable.

Fifteen members of the Board completed their term of office this Spring. Miss Florence Porter, retiring Junior Board Member, expressed her pleasure in having had the opportunity to serve in this capacity on the Provincial Board; and on behalf of the retiring members, Mrs. E. S. Brown spoke of the privilege and pleasure of having served as a Board Director. To the retiring members, Mrs. Lymburner expressed her pleasure in the association she had enjoyed with them during her term of office.

It was moved that letters of appreciation be sent to Dr. MacLachlan and the college personnel responsible for providing accommodation for F.W.I.O. to hold its Board Meeting at the O.A.C.
