WHEREAS pollution of air and water has become a major problem in Canada;

AND WHEREAS the phosphate content of

many laundry detergents is very high;

AND WHEREAS by the use of these phosphate content detergents we add greatly to the

pollution hazard;

THEREFORE BE IT RESOLVED that the members of the Federated Women's Institutes of Ontario respectfully request the Resources Minister of the Federal Government to seek legislation to ban or control the amount of phosphates allowed in laundry detergents.

## Eastern Ontario Area

WHEREAS at present the paint used in marking the center lines and divisional lines of the multi-lane highways becomes obliterated completely at times; in winter white lines are indistinguishable from snow; at night when pavement is wet, lines merge with the light reflections;

THEREFORE BE IT RESOLVED that the Federated Women's Institutes of Ontario request the Department of Highways to increase their efforts in the study of light reflecting, long wearing paint; or developing new methods of pavement markers imbedded in the highway surface; that prime consideration be given to areas where snow conditions exist up to five months of the year and to implement these better methods as soon as possible.

## **Hamilton Area**

WHEREAS there has been a loss of life at night as a result of poor visibility at rural level railway crossings unmarked by flashing lights when a long freight train is crossing;

THEREFORE BE IT RESOLVED that the Federated Women's Institutes of Ontario do all in their power to bring pressure on the Department of Transport to make it mandatory that all railway box cars, coal cars, flat cars and caboose be marked by some type of fluorescent paint in such a manner as to pick up headlights of an automobile.

WHEREAS we feel that November the eleventh should be truly a Day of Remembrance and not a holiday;

AND WHEREAS we feel our students would better realize what this day really stands for if they had a short Service of Remembrance in their school;

THEREFORE BE IT RESOLVED that the Federated Women's Institutes of Ontario request the Government of Ontario to declare that November the eleventh no longer be a holiday from school but a regular school day with a service or instruction on the real meaning of Remembrance Day.

## London Area

WHEREAS across the Nation half of all air pollution appears to come from motor vehicles (some say 60%), the other 40% from stationary sources;

AND WHEREAS it is claimed that auto exhaust is slowly damaging the sight, hearing and brain cells of the Nation's people;

THEREFORE BE IT RESOLVED that the Federated Women's Institutes of Ontario request the Government of Ontario to entropy the existing law — "The Air Pollution Control Act of 1967."

WHEREAS in purchasing frozen food—fruit, vegetables and dairy products it has sen found that some of the food is stale and the less and sometimes unfit for use;

THEREFORE BE IT RESOLVED that Federated Women's Institutes of Ontario everything possible, individually and collectly to see that the foods we buy are fresh.

WHEREAS our present system of local nicipal Councils provide people with an nomical and efficient form of democratic ernment, with consideration for and partition by the public;

AND WHEREAS the proposed Regarder Government, operating on a representation population could be detrimental to our areas, both in character and costs;
