Later during the Sessions a motion was accepted that judging of the Handicraft and Citizenship Projects be done at Area levels at the 1972 Conventions, with winning entries to be sent to the 1200 Bay Street office of the Federated Women's Institutes of Ontario by November 30, 1972.

It was reported that due to ill health Mrs. Ruby Lockman had resigned as hostess at the Adelaide Hoodless Homestead and that Mr. and Mrs. Owen Loveless have been appointed host and hostess.

It was announced that the next convention of the Federated Women's Institutes of Canada will be held in the week of June 10, 1973 at the Banff School of Fine Arts, Banff, Alberta.

The Home Economics Branch of the Ontario Department of Agriculture and Food

Miss Helen McKercher, Director of the Branch expressed appreciation to the retiring President and Public Relations Officer for their efforts. Reviewing the format of the Home Economics Branch, Miss McKercher said that originally it was begun as the Women's Institute Branch to provide an educational program for rural women; now one of its most effective roles is assisting girls and women by providing services that promote the development of people.

Speaking of the popularity of certain courses, Miss McKercher explained the work of the Branch specialists is to bring courses up to date by revamping projects, such as the 4-H Homemaking Club Unit "Separates For

Summer." She said, "This will be a new unit with the name "Sportswear With Knits."

Miss McKercher reported almost one hundred more 4-H Homemaking Clubs this past year with approximately one thousand more completions, making a total of nearly 27,000 4-H Homemaking Project completions this last year.

It was suggested that because of the national survey being undertaken it might be advantageous to stress nutrition programming.

Miss McKercher announced the appointment of Miss Margaret Myer as Supervisor of County Home Economists to replace Miss Rosemary Clark. Miss Myer previously worked for seven years as a Food and Nutrition Specialist with the Home Economic Branch, and recently was Chief Consultant of Consumer Service, Department of Environment of Canada.

The necessity for Board Directors to fill in and return promptly the sheets giving detail of the District Annual Meetings in their Subdivisions was stressed by Miss McKercher. Details should include whether or not they request a special speaker from the Home Economics Branch. These sheets to be mailed by February 28 to Mrs. Harvey Noblitt, newledged F.W.I.O. President.
