ASSISTANCE FOR CONVENERS OF RESOLUTIONS

Mrs. Austin S. Zoeller, Convener Are you interested in your Convenership? Do you take your job seriously?

Have you read the Resolutions section in the Handbook? — Pages 69-72.

If you can answer "yes" to these three questions, you'll do a fine piece of work as Resolutions Convener, regardless of the level to which you have been elected. As Provincial Convener, I am concerned at the lack of communications. Let's work together as a team. Don't wait until it's time for your report to go on before you wonder who the Conveners are, who should have sent reports on to you. It's your responsibility to know and find out.

Resolutions were one of the first Convenerships formed under F.W.I.O. This is the voice of Women's Institute speaking up in a concerned world. If you fall down on your job, we've lost that strong voice.

When Formulating a Resolution, Ask Yourself Is it a concern of the whole Province? Is legislation already being implemented?

Where shall I go for advice?

Is it written in such a way that it only contains statement of facts?

Beware

Of controversial wording Bias thoughts and ideas

Local Situations and Problems

If there is such a situation, a resolution sent direct to the local authorities can be sent immediately (if sustained by the level of Women's Institute concerned). Don't waste time sending to the next level if it does not concern all.

Sometimes a letter could be just as effective. If you have a local situation that concerns you give some thought to the idea, which would be more effective, a letter or resolution?

Proper direction in the "Therefore be it resolved" is often left to the next level. This not good enough, do the research yourself you will be satisfied it is going to the authorities you would wish.

Sustained resolutions: Don't forget the proposignatures and date, then send on with the covering material to the next level.

A mistaken idea: We ask that sustained resolutions whether at District or Area be circulated and studied by Branches and that the voting delegate be given some direction as "how to vote." Please this is only a guide for your delegate. After she has heard the discussion at the annual meeting she is attending the whole concept of the resolution might change and her vote might not be as original directed. She is your delegate, leave the decision to her, after all the facts have been presented.

How about it area conveners? I'm depending on you. Our Convenership has so much potential, let's develop the talents of all resolution conveners and urge every Branch to have resolution meeting.
