Where does the action come from? Resolutions are an excellent vehicle to express our opinions, however, there are various other methods in which the Resolutions Committee can work effectively. Letters, briefs, presentations at meetings all can have the same impact and even may gain results sooner.

Results of Branches pushing for action: A wing on a local hospital remained open which otherwise would have been closed; A local resolution to the town council has made a much-needed stop light a reality; Removal of dead elm trees; Preservation of the old Peel County Court House; Letters to Ottawa regarding reinstatement of rail services in Grey-Bruce; The start of a local park by municipal authorities; A letter sent pointing out that Erin Township was an understaffed medical area. This letter registering the general community concern brought results and now they are well on the way to a new medical centre with one doctor consenting to come and another expected.

Thirty-six resolutions were sustained at the 1973 Area Conventions. The Committee will do further research and these will be dealt with at the Semi-Annual

meeting.

An emergency resolution from Central area was lost. It requested the section of the Child Welfare Act be amended to coincide with the age of majority as defined in the Statutes of Ontario.
