Request advertising of alcoholic beverages be banned on TV. (A repeat from last year.)

Marc Lalonde states "the present-day factors relating to alcohol problems which most concern government and public are the widespread acceptance of drinking, the relative ease of obtaining an alcoholic beverage and the promotion of drinking as a desirable pursuit. With reference to alcohol advertising, I am concerned, as you are, that current promotion practices may have undue influence on consumption totals and patterns. . . frequent suggestions ban all advertising . . . far reaching effects . . . must be studied in total context of the expected results . . . potential economic impact. I recently announced a national alcohol information programme.

CRTC says—advertising is dependent on the law of the province—Ontario does permit advertising. Hon. Frank Miller: Advertising is up to the media, and under the jurisdiction of the Liquor Licence Board. Mr. G. J. Conroy.
