- To advise and make recommendations with respect to whether or not the collection and use of the SIN should be regulated or prohibited.

Emergency Resolutions

WASHAGO WI, SIMCOE EAST DISTRICT—request FWIO to ask Bell Canada to drop the proposal of a toll method for telephone calls.

Bell Canada replied that many of our customers prefer a flat rate for basic local service. "At the moment we are only discussing the possibility of conducting a trial of such a system, and the commission has announced that before any trial takes place, it plans to hold public hearings to provide an opportunity for a full discussion of the implications of measured service and related issues.

RAMSAYVILLE WI, CARLETON EAST DISTRICT—request FWIO to ask the Federal Government to enact legislation to require pharmacists to label medicines with precautions and that a copy of this request be sent to the Supervisor of the Ontario College of Pharmacists.

In the research it was found that some pharmacists were already labelling in this manner. Also the question was asked, is there already legislation to cover this question?

The 16th Triennial Conference, celebrating its Golden Jubilee, will be over by the time this issue is mailed. The meeting held in Hamburg, Germany will be sponsored by the German Society, comprising 10,942 local branches with a membership of 450,000.

Competition entries have been judged and arrangements made for the winning Children's Songs to be sung by a Children's Choir and broadcast by German radio.

A subscription rate increase to 2 pounds, commencing February 28, 1981, has been announced for the Countrywoman. **NOTE The subscription year begins in March.**

The flag tour, for Pennies for Friendship donation amounted to \$1421.56. This donation from Ontario will be added to the contributions by other societies from around the world.

A workshop was to have been held early in 1980 as FWIO's project in the Cameroons. It is too soon to have had a reply but hopefully the results will be made known at ACWW. It is encouraging to read that many of the "Save Sight" projects under Nutrition Education are continuing with assistance from the countries involved in that project. Mr. E. Roberts, United Nations advisor to ACWW said, "this little village project which we started in Madurai has led to a whole series of programs in different parts of the world."
