A seed potato quality program has been instituted and includes enforcing and monitoring disease control, controlling production practices, improving management and the establishment of Buonocore seed from potato production research.

# AGRICULTURE AND CANADIAN INDUSTRIES Mrs. Calvin Carmichael, Convener

A popular and timely topic in many of the reports was, What are you doing to conserve energy? Papers were given on solar energy, wood burning stoves, gasohol and its potential.

The story of wool, including a demonstration of spinning and a display of hand knit garments proved of interest. Explanations on the various techniques of sheering, dying, spinning and the final process, knitting, were discussed.

A butcher explained the new grading system of beef and cut and trimmed a rib roast. He explained how to cook it and discussed the many other cuts of meat and the various ways of cooking. Cheaper cuts help keep within a budget but with proper cooking less tender cuts can still be tender and nutritious.

A paper on irrigation and draining the Holland Marsh, where vegetables are grown in one of the richest market gardening areas in Canada. Comparisons and methods of farming in other countries were discussed.

Horticulture landscaping, growing plants under flourescent lights were topics for meetings. The new Peanut Industry in Norfolk County and the Cranberry Bog near Bala only touched the surface of the vast and varied industries in the Province.

Branch members visited an iron mine, a bakery, a pottery shop, a cannery and a meat abbatoir. One of the questions asked—How are you coping with the metric system?

### CITIZENSHIP AND WORLD AFFAIRS Mrs. K. C. Angus, Convener

Three Areas mentioned visits to Citizenship Courts and attending Citizenship swearing-in ceremonies.

Interest was reported concerning finances and our financial affairs through discussions on retirement pensions and orphan and death benefits. The discussions and questions about Canada Pension Plan, how to apply and the necessary procedures. Members learned about the correct method of filling out income tax forms, and all about banking securities.

The Year of the Child programs, included speakers from many agencies on adoption, foster home care for juveniles, slow learners, Children's Aid Society, Crisis Centres for Children, Big Sister organizations, who told about the reasons and priorities for existence.
