FWIO request the Ontario and Canadian Governments to print Income Tax Forms, Insurance and Government documents and official reports by Bureaucrats, in everyday language that the general public can readily understand.

## HAMILTON AND GREY-BRUCE AREAS

FWIO request the Ontario Ministry of Transportation and Communications, the Canadian Radio-Television and Telecommunications Commission and J. C. Thackray, President of Bell Canada to deny the "Usage Sensitive Pricing Proposal" on telephone calls.

### **GREY-BRUCE AREA**

That FWIO request the Ontario Minister of Education, and the Ontario Minister of Health to work together to promote the sale of nutritional snack foods in Ontario schools, i.e. fresh and dried fruits, nuts, pure fruit and vegetable juices, milk and cheese products, and, to discourage the sale of "junk food" in Ontario school cafeterias.

Many people who are disabled for long periods through crippling diseases wish to stay in their homes. FWIO request the Ontario Government to provide financial or other help to such disabled people.

#### HAMILTON AND NORTH CENTRAL AREAS

FWIO urge the Federal Government to instruct the Food and Drug Directorate to:

(1) Immediately initiate a code system (similar to that on "care" labelling of fabrics) to indicate the proportion in each food product of, 1-Natural whole food, 2-Caloric content, 3-level of nutritional value, Number of food additives.

(2) Include staple food products such as bread, milk and ice cream under the code labelling system.

#### ONDON AREA

FWIO request the Ontario Government to restrict the purchase of Ontario farm land with foreign capital and/or by non-resident purchasers.

#### ORTH CENTRAL AREA

FWIO request the Provincial and Federal governments to initiate a public dialogue to provide information as to the hazards and benefits of nuclear development.

FWIO request the Department of Consumer and Corporate Affairs to do everything possible to improve the quality of nylon zippers, used in clothing.

FWIO request the Government to enact legislation to have coupons removed from packages and the price of these commodities lowered accordingly.

FWIO request the Attorney General to enact or enforce legislation to require the offenders to make restitution within reason, where applicable, or to penalize the offenders in a manner severe enough to deter further acts of wanton destruction.

FWIO request the Canadian Government through its membership in the World Health Organization, to (a) encourage governments in developing countries to strengthen and strictly enforce regulations over the infant-food industry, (b) urge the infant food industry itself, to change its emphasis in developing countries from formula sales to the development and sale of cheap weaning foods.

## NORTHERN AREA

At present time there are apparently no laws existing which would prevent the making and use of recordings of subliminal message suggestions. FWIO request the Ontario Government to take urgent steps to enact legislation outlawing the making and use of such recordings in Ontario and that the Government also be asked to urge the Federal Government to enact similar legislation for the whole of Canada, or if such a law exists that it be enforced.

### SOUTHWESTERN AREA

The pricing code that appears on all products for the use of computers could take the place of price stickers at any or all stores. FWIO request the Ministry of Consumer and Commercial Relations to enact legislation to the effect that the price stickers still remain on each article, so every individual can read readily.

FWIO request that legislation be enacted requiring all automobile safety belt assemblies to include a standard releasing mechanism capable of being operated under all emergency conditions and located in a standard location, relative to the individual driver and passenger.

ALSO, that automobile manufacturers be required to develop safety belt restraining devices that offer maximum protection, coupled with greater comfort and convenience for occupants of motor vehicles.

# TRENT VALLEY AREA EMERGENCY RESOLUTION

FWIO urge the Department of Health and Welfare or appropriate Federal body to put in place proper safeguards on such products, i.e. tampons, and define standards for materials used to insure the health and safety of Canadian women.
