ELECTION FOR A 1-YEAR TERM ONLY. DISTRICT DIRECTOR REMAINS IN OFFICE UNTIL AFTER RATIFICATION OF NEW DISTRICT DIRECTOR on day of Annual Meeting.

Retiring Board Director (FWIO) shall remain on District Board of Directors for 1 year. District Board to decide if she has a vote, and shall present FWIO Board report at District
