ADDITIONAL FACTS: Each Provincial Board Director is elected at Area Convention, only by the voting delegates of the Districts in that Subdivision.

TERM OF OFFICE: 3 years. Must be re-elected for following 2 years at District Annual and Area Convention. The alternate, elected, must remain for the same period.

The 32 SUBDIVISIONS are divided into 4 Divisions from which regional Vice-Presidents are elected by the Provincial Board Directors for one year, at each Annual Board Meeting of FWIO.

EASTERN DIVISION: Subdivision 1 - 6 Mrs. Hugh Coons

WESTERN DIVISION: Subdivision 7 - 17 Mrs. Geo. Dixon

SOUTHERN DIVISION: Subdivision 18 - 25 Mrs. Keith Hiepleh
(No Vice-President is elected from Division in which President resides).

NORTHERN DIVISION: Subdivision 26 - 32 Mrs. Arthur Mills.

RETIRING PROVINCIAL BOARD DIRECTOR:

Those Provincial Board Directors who have attended their last semi-annual FWIO meeting in April, still have duties until after their Convention in the Fall.

Those Board Directors will give their final FWIO report at the District Annuals in May.

A FEDERATION REPRESENTATIVE will be elected at District Annual to replace the retiring Board Director.

The duties of the newly elected Federation Representative will begin at the conclusion of the District Annual. (HOWEVER, the retiring Provincial Board Director shall remain on the District Board of Directors for one year) with or without a vote.

The newly elected Federation Representative will be expected to carry out her duties at the Area Convention; also,

The retiring Provincial Board Director will perform the duties expected of a Board Director as well.
