MISS MOLLY MCGHEE

Miss McGhee presented the report of the Home Economics Unit, Rural Organizations and Services Branch, OMAF.

"It is my pleasure to once again present to you the report of the former Home Economics Branch. As most of you are probably aware, the Branch has been integrated into one new, large Branch, the Rural Organizations and Services Branch, which consists of the Home Economics, Junior Extension, and the Agricultural and Horticultural Societies Units. The new Branch hopes to have a Director appointed within a few weeks to co-ordinate the activities of the three units. This person will report to the Executive Director of the newly created Education and Research Division, who in turn reports to Dr. Clare Rennie, the Assistant Deputy Minister in charge of Technology and Field Services.

The past year has been an extremely busy one for the Home Economics staff, with a continued increase in demand for our services, while we have experienced a complete freeze on hiring since last September. We have nine vacancies at present, six in the County and District offices and three in Toronto, as well as three women on maternity leave. Things have not been easy, but of course, all of the staff have carried out additional duties with their usual good will. We will all be very happy when the reorganization has been completed, we then hope that we will be allowed to hire new staff. In the meantime I would ask you to be patient and to bear with us. We have tried to hire Home Economists on a temporary basis to carry out the work.

Our statistics have really surprised us all, this past twelve months. The number of clients and those seeking Home Economics information has, for a second year in a row, increased dramatically. The numbers are as follows:
