legislation to prevent further tragic accidents of this nature, to increase the unrealistic fine imposed on those found guilty of insecure loads as related to the fine imposed on those found guilty of overweight loads and that action be taken immediately.

WHEREAS one in ten Canadian women are battered by the men they are married to or live common-law with: and

two thirds of all divorce applications are filed by women; more than onequarter of these divorces are requested on grounds including physical cruelty; and

WHEREAS eight of ten women seeking shelter in a Canadian Transition House had been beaten while they were pregnant; and

one out of three residents in homes for battered women had been beaten weekly or daily; and

WHEREAS 45% of the Canadian population lives in an area without the service of a shelter and beaten women in these areas have nowhere to seek refuge;

THEREFORE BE IT RESOLVED that the Federated Women's Institutes of Ontario urge the Government of Ontario to take steps to see that funding is made available for the provision and upkeep of shelters for battered women.
