The constitution that was written then, with a few changes over the years, has stood us in good stead. resulting in our being recognized as one of the staunchest guardians of our families, our health, and our heritage whether it be of the countryside, arts and crafts, traditions, behaviour, democracy, truth, justice, tolerance or fellowship.

Times are changing now, but ours is not the first generation to experience change. The recommendations of the committee were presented to the annual FWIO board meeting in November and the board accepted them.

How do you feel about them? It is to be hoped that every branch will conscientiously study and evaluate the proposed changes and make its views known to the president and the board. You are a member and FWIO is your organization.
