# Membership Recruitment Challenge

The Penage Road Women's Institute, Sudbury District, North Central Area, won the Membership Recruitment Challenge for 2003-2004 with the addition of 10 new members. The challenge is being issued once again for 2004-2005. Once again, the Branch who gains the most new members in the period up to March 31, 2005, will win one paid registration to the FWIO Provincial Conference, plus \$50 in FWIO Bucks. The second place Branch will win \$100 in FWIO Bucks and the third place will win \$75 worth of FWIO Bucks.

New Membership Recruitment Packages have been developed. Branches will receive five Packages from the Provincial Office and ten additional Packages at the ROSE Workshops. After that, the Recruitment Packages will cost \$1 through the Office.

#### So, what are FWIO Bucks?

For each new member obtained, Branches will receive a \$5 FWIO Buck. They will be mailed with their fee receipt and can be redeemed when purchasing supplies, brochures or Membership Recruitment Packages.

#### **New Membership Category**

Next year, a new membership category to be known as WI Alumni will be introduced. It is considered more of a social membership for members who are over 75 years of age and who have been a WI member for at least 20 years. The membership will be with FWIO only and will cost \$25; Branch fee charges will be over and above the \$25.

**Note:** This membership category will take effect with the fee submissions in April/May 2005.

# **Resolutions Sustained**

- That FWIO urge the Federal Government to immediately look into the huge discrepancy between what the farmer presently realizes for the price of beef and what the consumer pays in the retail store.
- That FWIO urge the Federal and Provincial Governments to open the borders to Canadian beef, dairy and all agricultural commodities and return to pre-BSE trade practices.
- •That FWIO urge the Federal and Provincial Governments to realize the dire situation of farmers and to look for ways to expand processing capacity so as to deal with escalating numbers of cattle.

#### **Area Voting Delegates**

Provincial Advisory Councillors will be advising the Areas that only one Voting Delegate from each Area is able to attend the FWIO Annual Meeting and that the Voting Delegate and their Alternate should be elected by ballot at the Area Convention. FWIO will pay the expenses of the Area Voting Delegate to attend the Annual Meeting.

**Role:** Area Voting Delegates are the liaison between Regional Board Directors and members.

#### Responsibilities:

- attend the FWIO Provincial Meeting, with full voting rights and expenses paid
- •be a member of the Area Convention Committee and Executive
- be paid allowable expenses for communication to a maximum of \$50 per year
- ·be a member in good standing

Selection: Area Voting Delegates are elected annually by ballot at the Area Convention for a maximum of three years. Their alternates are also elected annually.

Watch for a letter from the FWIO President to your Area explaining these changes.

#### **Branch Related Items**

- Branches that are amalgamating may keep the same name or a hyphenated version of the two names. As well, they may use the inception date of the older Branch.
- FWIO Board accepted a recommendation making it possible for members to belong to and to hold office in more than one Branch.

#### Coordinators

The FWIO Board passed a motion stating that the title of ROSE, Advocacy and Tweedsmuir Coordinator be used at all levels of the organization.
