Branch Lobbying Convenors

- follow the *Handbook* pages 35 and 36; also refer to pages 81 to 84

Resolutions of Local Importance

- follow the *Handbook* page 83, item 7. (a) and (b) (i)

Resolutions of Provincial, National and International Importance

- may be submitted to any District meeting, including the District Annual
- follow the *Handbook* page 83, item 7. (a) and (b) (i)

District Lobbying Convenors

- follow the *Handbook* pages 42 and 43; also refer to pages 81 to 84

It is the responsibility of the District Convenor to get the resolution(s) out to the Branches in her District. At the same time,

she should advise the Branches of the date of the meeting at which the resolution(s) will be discussed. If a resolution arrives too late to be sent out to all Branches before a scheduled meeting (the *Handbook* says ten days, but I believe a full month would be wisest in order to accommodate Branch meetings), then it should not be considered until the next meeting. (This is just as it is with Board meetings.)

The Branch Resolutions Convenor, or someone designated by her, should be prepared to address the resolution when it is up for consideration. Since the membership will be aware of the resolution and the date it is to be discussed, there should be a representative from each Branch at the District meeting; that is when input from the membership is obtained. If the resolution is sustained at the District level, the District Resolutions Convenor follows the *Handbook*, pages 83 and 84, item 7. (a) (ii).

Resolutions printed in the *Home and Country* have been sustained at Board. Sometimes I write about resolutions which have been submitted and returned (for varying reasons) or are currently being researched. This keeps members aware of what is happening across the province.
