She explained that the major achievements on the international front included: Foreign Affairs Minister Lloyd Axworthy's speech to the United Nations on human rights for the women of Afghanistan; WI financial support used to educate people about female genital mutilation in Africa: the launch of ACWW Canadian Area member societies Iodine Deficiency Project; and, the first FWIO/Michigan Exchange.

Health Program

FWIO Fundraiser Mike Paquet addressed members at the Annual Meeting; he began with the preliminary intiatives already in place. Based on discussions with Board, Paquet outlined the organization's primary funding requirements: the ACWW 2001 Conference; the Erland Lee (Museum) Home and educational programs. Paquet sees the ACWW 2001 Conference as an "overwhelming opportunity." In his efforts to seek sponsorship and funding, Paquet "relishes establishing relationships with a global audience at the corporate level."

Communications Workshops

A series of Communications Workshops were organized for day two of the Annual Meeting to clarify the roles and responsibilities of the Provincial Advisory Council (PAC), the five Coordinators and the Provincial Board of Directors. The workshops provided a great opportunity to offer constructive solutions in areas of concern.

FWIO President Christine Reaburn and Past President Arthena Hecker facilitated discussions for the Provincial Advisory Councillors (PAC), Eastern Regional Board

Director Rosemary Moran facilitated the workshop for Coordinators. It was organized with assistance from Provincial Board members Marg Harris, Vera Miner, Billie Power and Margaret Wilton, Jim Brown of Strive!, a private company devoted to helping maximize the effectiveness of people and organizations through leadership development, spoke to the Board of Directors.

Positive discussions ensued among all groups on a number of points, but with a focus on improved communications. At the PAC Workshop suggestions on how to best communicate within their Subdivision were discussed. They noted that time should be set aside at the next annual meeting to get together as PAC and to meet with Board Directors. Discussion also focused on the clarification of report forms, volunteer hours, FWIO's charitable status and nominations and elections.

Coordinators wished time together as a group to formulate a cohesive strategy for their work within the organization. They too wished time together as a group, as well as time to meet with the Provincial Board and with their respective committees. Recommendations from this workshop will be forthcoming at Board.

As in past years, the primary focus of Strive's workshop for the Provincial Board of Directors was to highlight the essentials of the law for an incorporated non-profit organization. Strive concluded by reinforcing the two key functions of Board Directors are to "direct" and to "protect."

Directors noted that they were pleased with the reduced size of the Board and the fact that they could easily communicate with one another via fax. The interaction among Board Directors was constructive as they discussed and offered concrete solutions to help resolve areas of concern.

Everyone participated in an afternoon workshop entitled "Communication and Team Building Development." Randa Yacoub, from the Ontario Agriculture Training Institute (OATI), facilitated the workshop.
