William Box with 14 years experience was nominated Leonard Culhane and Mack Pender.

Campbell Brisco and Lorne Briscoe sponsored Denis J Enright who has been a member of council for seven years.

Lorne Briscoe who took his seat in council in 1959 was nominated by Maynard Elliott and Campbell

Bernard Luker was nominated representative on the Renfrew and

Thomas Munhall, did not qualify.

D C McLaren was chairman of the ratepayers meeting followed nomination.


All the candidates except Mr Foy, who was not present, spoke briefly and thanked those who had nominated them.

by Lawrence Naismith and Alex District Collegiate Institute Area Board discussed the rising cost of Harold Foy, whose name was education and asked to be relieved proposed by Bernard Luker and of his duties at the end of the year.

The reeve, John L Hodgins, compared tax rates for 1959 and 1960. The county rate was decreased from 14.2 mills to 14 mills but this was offset by a new levy of 1.4 mills to cover grants made by County Council to Renfrew County hospitals.

The council had no control over school taxes which were levied by the various public, separate and high school boards.

The township levy was increased five and one half mills. Three mills of this was for a grant of \$4,000 to Renfrew Hospital in 1960. The Butler bridge across the Bonnechere River was repaired under a supplementary road by-law with the province paying 80 per cent of the cost.

A new engine and hose was purchased for fire protection in the township at a cost of \$535. These two items accounted for more than two mills of the increase in the township levy.

Bernard Luker declared his intention to qualify for office.

The clerk directed the attention of the ratepayers to the financial statement for the first ten months of the year which was posted in the Municipal Building. She paid tribute to the time and effort given by members of council to the affairs of the township and asked the ratepayers to express their thanks to James McAdam who had served them for 25 years.
