

J. L. Hodgins given 17th acclamation 1958



JOHN L. HODGINS

Admaston Township council for 1959 was elected by acclamation.

John L. Hodgins who was warden of Renfrew County in 1958 was the only man nominated for the office of reeve. Mr. Hodgins will be starting his seventeenth year as a member of council and has never been opposed for office since the year he entered council as a councillor. After five terms as councillor he succeeded Duncan Campbell who retired as reeve.

The veteran member of council James McAdam of Shamrock will commence his twenty-fifth term of faithful service to the ratepayers of Admaston.

William Box has completed 12 years as a member of council and Denis J. Enright has served since 1954.

Clifford Peever, a member of council for 13 years was nominated but failed to qualify. Mr. Peever has sold one of his farms in Northcote and moved to Renfrew to reside.

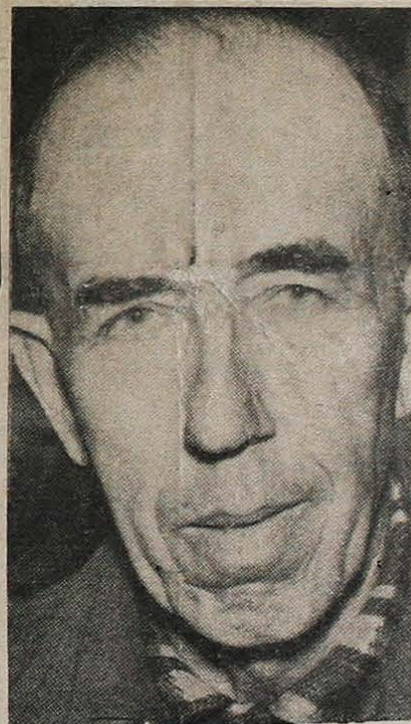
Lorne Briscoe of Northcote is the new member of council.

James Campbell was chairman of the ratepayers meeting which followed nominations. Twenty persons were present and all were apparently well satisfied with the work done by council as no criticism was voiced.

The reeve and Councillors Box, Enright and McAdam spoke briefly on what had been done by council in 1958.

Mr. Peever was not present.

The new nominee, Lorne Briscoe, told the gathering he would not qualify if Mr. Peever would consent to let his name stand.

Villages—Cobden, 754; Eganville, 1,173.

Towns—Arnprior, 4,319; Pembroke, 5,500; Renfrew, 3,689.
