Kinloss township council has approved the building of a school on part of lots 2 and 3, concession 3.

A public meeting was held Oct. 6 to consider the amendment to the comprehensive zoning bylaw. The building of the Mennonite school was deemed to conform with the general intent of the official plan and satisfied the requirements of the provincial policy statement relating to agriculture.

Council has implemented a \$30 flat fee, along with a building permit application, for any building being erected on a property which requires a new address number to be allocated. The cost includes the sign, post,

and installation costs by the road department employees.

Kinloss township council has decided to incorporate the recovery cost of 9-1-1 property signs and labor to erect them into the 1997 mill rate. Council had first planned to do a separate billing but found out that abutting municipalities were doing the former.

Herman Fischer attended the May 22 meeting to request an additional two loads of stones for fill in a hole he dug on municipal road allowance, on Sideroad 5. Council agreed to give him the two loads free of charge, and

Council agreed to proceed with a road maintenance budget of \$287,000 and a construction budget of \$83,000. This will be incorporated into the overall budget and be available for review at the next

A request for 20 free garbage bags tags for churches withing the township was approved, if requested by the church.

Although full guidelines on the new infrastructure works program have not arrived, council tentatively plans to submit an application for some

funding on the new culvert for Conc. 3 and 4.

On a \$10,679 project, if the application was approved, the municipality would be responsible for \$3560, and the federal and provincial government

would pick up \$7,199. Mark Becker, clerk, said even if they can get the above approved, the total cost of the culvert project would be much greater than infrastructure funds would cover.

In connection with that project, council approved two pipes rather than one.

Fence bylaw gets amended in Kinloss

Kinloss township council did some "housekeeping" when they met on Sept. 15. The bylaw requiring and regulating fences around swimming pools and manure pits was amended. OCT. 1997

Previously the bylaw set a maximum fine of \$2,000 for anyone in contravention. Now there is no set fine and the penalty will be determined by the laws in place when contra vention takes place.
