There's high praise for two professional truck drivers who blocked off traffic on Highway 401 April 20 to prevent a possible collision.

At approximately 11:45 a.m. April 20, OPP received a call of a vehicle traveling eastbound on Highway 401 in the westbound lanes, east of Port Hope. After traveling 14 kms, the vehicle then crossed the median and entered the eastbound lane just east of Nagel Road.

Two truck drivers blocked the highway near Lake Road in Cramahe Township allowing police to stop the vehicle and avoid a possible serious collision.

James Willis, 76, was arrested for dangerous driving and will appear in Cobourg court May 17.

The Northumberland OPP have publicly thanked the truck drivers who assisted in the incident "ultimately preventing any injury to those traveling the area."

On Sunday, December 20, 1998, Merlin Gray was found dead, lying in a ditch on the Alderville First Nation Territory.

The Northumberland County Crime Unit and Ontario Provincial Police Criminal Investigation Branch, Major Cases, has conducted a lengthy investigation, and have determined the cause of death to be blunt force head trauma, complicated by hypothermia. Mr. Gray's death has been ruled accidental in nature and no foul play and no foul play is suspected.

Sixteen-year-old Christine Anne Phillips of Bewdley has been missing since Friday, April 23. She has last seen around 8 p.m. when she left her residence and got into an unknown vehicle driven by a female. Foul play is not suspected.
