It was a busy weekend on the 401 for Northumberland OPP Central Region 401 Traffic Unit. There were various accidents between Brighton and Port Hope.

At 5 p.m. August 8, westbound weekend traffic was very heavy with the occasional slow-down. Near Grafton, traffic began to slow and two vehicles were unable to stop. The first vehicle, a van, struck the rear of a Mercedes. The Mercedes went out of control and struck a westbound Volkswagen, then crossed the centre median rolling several times. A fourth vehicle travelling behind the car also lost control when braking and crossed the centre median, coming to a stop on the south embankment of the eastbound lanes.

The two occupants of the Mercedes, Christine Rotenberg, 51, and Sarah Rotenberg, 18, both of Toronto, were transported to Cobourg hospital, treated and released with minor injuries.

The driver of the van, Nieda Lubian, 35, of Italy, and the driver of the fourth vehicle, Kathirgamu Cheverlharan, 29, of Kingston, were both charged with follow too close.

Traffic eastbound was backed up for 30 kilometres and the 401 was reduced to one lane for 1.5 hours. Westbound was also congested for approximately 20 kilometres as motorists stopped to look.

commends an unknown US tractor trailer tanker driver. The tanker, loaded with dangerous goods, was faced with the two vehicles that crossed the median. The professional truck driver, after breaking heavily, still faced the possibility of colliding with the vehicles but headed for the gravel shoulder. With his skill, he managed to stop the transport without collision, injury or unsettling his transport.

While travelling eastbound on Highway 401 Sunday, August 8, OPP Constable Bettina Schwarze observed a vehicle in the left lane interfering with traffic. When attempts were made to stop the vehicle, it halted in the passing lane.

The motorist was directed to pull over but instead proceeded eastbound. Several attempts were made over a six-kilometre stretch to stop the vehicle and were finally successful near Grafton.

Visuvalingam Ampalavanapillai, 62, of Scarborough, was charged with fail to stop for police, interfere with traffic and fail to keep right less than normal speed. He was cautioned about his slow speed and told the left lane is only for passing.

A short time later, Constable Schwarze located the same vehicle driving in the same manner. The driver was stopped a second time. As the motorist pulled out onto Highway 401, the driver forced two vehicles to take evasive action.

Further charges are pending.
