## One dead following Cramahe fire

One person is dead following a structure fire in Cramahe Township on Saturday morning, December 29.

The one-room shack was believed used by snowmobilers and was located just off Pogue Road near Dingman Road in Cramahe Township.

When Colborne Cramahe firefighters arrived shortly before 7 a.m. the 10' X 14' structure was engulfed in flames.

Initially firefighters were informed by a nearby resident at least one person may have been trapped in the fire. But firefighters feared there was the possibility more than one person perished because there was a snowmobile and at least one vehicle near the scene.

Fire Chief Gary Cammack said the fire was hard to access as it was several hundred feet off the roadway.

"It was way back in the woods. We had to drag hose through trees, down through a creek to the scene."

A van parked beside the shack was also destroyed in the blaze. After the fire was under control, firefighters searched the charred remains and found one body.

Lakeshore Paramedics were called for standby, but were released once the body was found. OPP cordoned off the area and the Fire Marshal was called in to determine the exact cause of the fire.

At press time police have not determined the identity of the victim.

This has been the worst year for fire fatalities in Colborne/Cramahe Township and Chief Cammack said it's taking a toll on the firefighters: "It's quit emotional for the firefighters. They realize it is part of their job, but some of them it does bother them, but that's human nature."

## Cramahe man arrested after joint police operation

A Cramahe man faces several charges after he was arrested following a joint police operation during the early morning hours of January 3.

John Knapman, 35, along with Jim Ferguson, 42, of Cobourg, were both arrested for a break and enter at a Quinte West convenience store shortly before midnight on January 2.
