I have been fortunate enough to have enjoyed several occasions at the centre, including birthday and wedding celebrations, memorials, New Year's and Hallowe'en, etc., etc. These sort of occasions, I fear, will now not be so readily available to us.

If the managers of our community who voted or proposed this move are reading this, I would ask you to revisit your decision; rethink and

then trash the idea. To me, at least, it makes no sense.

"Too costly" and "poorly managed", I believe, were reasons given for its projected closing. Hmmm. I can think of another way. Reduce redundant town staff jobs (why do we have a tourism coordinator? I actually believe the Keeler Centre staff are better at that). And what exactly is a Director of Community Services? We had one last year and he was also head of the Keeler Centre so two for the price of one. But, he was dismissed. Keeler Centre decision can be win-win

Once again, our community finds ourselves in an emotional and controversial situation regarding the Keeler Centre. Our elected officials who we have elected have made a tough decision to discontinue a catering business.

The previous council wrestled with the issue since the operation started. In their wisdom, be it right or wrong, they dismissed the previous manager, hired a new one who was made aware of the problems and was given a mandate to fix the problems, relieving the taxpayers of having to pay the losses. Now, going on two years later, the problems appear to be still here with no fix in sight.

Ms. Rusaw will have the opportunity to cater to any group large or small, special occasion functions, private weddings, etc., hiring who she wishes to work for her, creating her own menus, her own prices without the interference of management, council or any taxpayer, and an opportunity to build a lucrative business for herself — not tied to the Keeler Centre — catering to whoever, whenever, wherever she wishes.

As for the Keeler Centre, nothing changes. Sill the same great place offering the same service for the users, an opportunity to choose a caterer of their own choice. I believe this creates a win/win situation for everyone.

As for council, it relieves them of the pressures of operating a business which is better served by private enterprise; relieves them of employees and the administrative cost of the same; gets them out of running a business which, in some cases, actually competes with some taxpayers in the community; will reduce insurance costs; an opportunity to adjust salaries and be in line with other municipalities, owning and renting a facility; and not having to answer to the taxpayers about using tax dollars supporting a losing business.

As for the taxpayers, it would be a comfort in knowing their tax dollars are not subsidizing the users of the Rotary Room. History very clearly tells us government bodies — municipal, provincial or federal — should not be involved in operating business. They are always inefficient, and annually we can always see that, as their answers are always the same: raise taxes to pay for it and we as taxpayers can do nothing except pay and complain about the increases.

As a supporter of the Keeler Centre, I believe this situation now gives everyone, the service clubs, the hockey leagues, the figure skating clubs, the Firemen's Association and other community groups, an opportunity to be creative in their fundraising attempts and the freedom of choice.

I think we should all support the situation. Give it a try. We are doing nothing different than most other municipalities.
