escape.”

The youth and Mr. Vickers appeared in Cobourg court Thursday afternoon, June 12, for a bail hearing.

The younger accused waived the reading of the charge against him. Both are subject to a non-communication order forbidding contact with a list of 13 individuals who are potential witnesses.

Neither has retained counsel as yet and both were assisted by duty counsel John Carroll.

Mr. Vickers will remain in custody “until (he is) dealt with according to law and while awaiting a (subsequent) bail hearing.”

Although Mr. Vickers objected to the order banning communication with the 13 people on the list, the justice of the peace did grant the non-communication order.

Justice of the Peace Joanie Glover also banned publication of evidence introduced at the bail hearing.

Mr. Vickers's case will be dealt with by video remand at 9:15 a.m., June 20.

The youth will be held in custody where there are no video facilities, so he is expected to be back in court in person next Friday at 9:30 a.m.

Northumberland OPP were notified two weeks ago, May 29, by concerned family members regarding the disappearance of Ms. Barnoski.

On May 28, a member of the public found Ms. Barnoski's red 1999 Pontiac Sunfire abandoned in a secluded area west of County Road 25 across from Newman Road, south of Warkworth.

Police have conducted an exhaustive search of the area but have not yet located Ms. Barnoski. Additional searches were ongoing yesterday (June 12).

OPP advise there is no risk to public safety in relation to this case.

The investigation is ongoing and under the direction of Detective Inspector Dave Quigley of the Criminal Investigation Branch (CIB).

**Murder charge
in missing
woman case**

A 14-year-old youth has been arrested and charged with second degree murder in the case of a missing Warkworth woman, Michelle Noella Barnoski, 33.

Northumberland OPP have also charged Marc Vickers, 34, of Warkworth, with being an accessory after the fact to second degree murder. Police say Mr. Vickers lived in the same house as the missing woman.

Ms. Barnoski has still not been found.

The exact charge against Mr. Vickers is, “knowing (the younger accused) had murdered (Ms. Barnoski) did assist him for the purpose of enabling him to
