CRAMAHE TOWNSHIP -Residents who have not seen an increase in assessment this year will see their municipal portion of their tax bills go down, but most properties did see an increase, says Cramahe treasurer Mora Chatterson.

Council passed a bylaw Tuesday night approving a 2009 budget levy increase of 1.86%, but the tax rate (formerly called the mill rate) decreased by 7.13%.

In apparent disbelief, resident Fern Dobson asked for clarification, stating that on a property assessed at \$150,000 last year, the municipal portion of the tax bill would have been \$1,257, yet this year's bill

She was assured her numbers were correct, as the tax rate did in fact decrease.

"I think we have the lowest levy increase in Northumberland County," said Mayor Marc Coombs.

The township held three budget meetings in March, with the final meeting held on Mar. 31.

The levy to taxpayers is \$3,906,787, says Chatterson.

"Based on the fact that the average house assessment increase was 10%, a house with an assessment of \$165,000 will pay \$1,284.70 in municipal taxes in 2009," said Chatterson. "Last year a \$150,000 house would have paid \$1,257.58 municipal portion."
